PREAMBLE / INTRODUCTION

National Institute of Fashion Technology (NIFT) was set up by the Ministry of Textiles, Government of India in 1986 which has been accorded statutory status under the Act of Parliament in 2006 (NIFT Act 2006) for the promotion and development of education and research in the field of Fashion Technology. NIFT provides fashion business education across the country through its network of 18 centers. It provides four years under graduate (UG) program in design and technology, two years post graduate (PG) program in design, fashion management & fashion technology and short duration education program to address the specialized needs of professional and students in the field of fashion. NIFT has its head office at New Delhi with its campuses located at Bengaluru, Bhopal, Bhubaneswar, Chennai, Daman, Delhi, Gandhinagar, Hyderabad, Jodhpur, Kangra, Kannur, Kolkata, Mumbai, Panchkula, Patna, Raebareli, Shillong and Srinagar.

The Bengaluru center has been set up since August 1997 with undergraduate and postgraduate programs.

Tender Notice:

NIFT Bengaluru invites sealed Tenders under two Bid systems for Design Collection Show / Choreography, as per the requirement/ specification mentioned in the Price Bid. The tender bids duly filled in all respects enclosing necessary documents may be addressed to The Director, National Institute of Fashion Technology (NIFT), CA Site 21, 16th Cross, 27th Main, HSR Layout, Sector 1, Bengaluru – 560 102 **so as to reach on or before 11:00 am, 07.05.2024** or the tender may be dropped in the Tender Box placed at 'A' Block of NIFT, Bengaluru Centre.

Technical Qualifying Criteria:

1. NIFT invites sealed Tenders under two Bid systems for Choreography for their Design collection Graduating **Fashion Show on 31st May 2024 (Tentative)**. The tender shall be submitted in two separate sealed envelopes, as per the quantity and specification mentioned in the Technical Bid (as per **annexure 'A & A-I'**) and the Price Bid (as per annexure 'B') which should be super scribed in the envelopes. Both these sealed covers are to be put in a bigger / outer cover which should also be sealed & duly super scribed as "Choreography for **Design Collection – 2024**". The duly-filled tender in all respects, enclosing necessary documents should be addressed to "The Director, National Institute of Fashion Technology, CA Site 21, 16th Cross, 27th Main, HSR Layout, Sector-1, Bengaluru - 560 102" or the tender may be dropped in Tender Box placed at 'A' Block of NIFT, Bengaluru Centre, to reach on or before the scheduled time and date.
2. The tender shall be submitted in the official tender form only. If submitted in any other form the same shall be summarily rejected. No tenderer shall be issued more than one tender form.
3. Tender form is free if downloaded from the website <https://www.nift.ac.in/bengaluru/tenders>.
4. No paper shall be detached from the tender document.
5. Tenderer shall enclose a demand draft / pay order on any Nationalized Bank/ Scheduled Bank of **Rs.50,000/- in favor of NIFT** payable at Bengaluru as the non-interest-bearing Earnest Money Deposit [EMD]. Offers received without EMD will be rejected.
6. For exemption of EMD, supporting documents should be attached (a copy of the MSME/ NSIC registration certificate along with Enclosure - I).

7. The Earnest Money to those other than the lowest bidders will be returned within two weeks of the opening of the tenders.

8. The name and address of the tenderer shall be written in the space provided and no overwriting, correction, or insertion shall be permitted in any part of the tender unless duly countersigned/ Corrigendum passed by the tenderer. The tender should be filled in and submitted in strict accordance with the instructions laid down herein: otherwise, the tender is liable to be ignored.

9. The tender is liable to be ignored if complete information is not given therein, or if the particulars and data (if any) asked for in the Schedule to the tender are not filled in.

10. NIFT shall in no way be responsible for any default about any statutory obligation and the service provider/ vendor/ contractor will indemnify NIFT in case of any damage or liability, which may arise on account of the action of the firm.

11. The tenderer must sign along with the company seal on every page of the tender document as a token of the acceptance of the tender conditions.

12. The tender shall be accompanied by the relevant documents including Annexure "A" – a list of organizations where the choreographer has recently provided needs to be enclosed.

13. The service provider shall deposit 10% (including the amount of EMD) of the quoted price as Security Deposit by Demand Draft/ Bank Guarantee in favor of NIFT, payable at Bengaluru, which will be returned after the successful completion of the show/ event and after adjusting dues, if any.

14. These rates will be valid for **60 days** from the tender document's opening date.

15. No tenderer will be allowed to withdraw the tender rates after the opening of the tender (price bid). If any tenderer withdraws the rates the EMD amount deposited by him/ her will be forfeited and he/ she will be disqualified from participating in any future tender of this Institute.

16. Rates should be offered unconditionally and if rates are submitted with any condition the tender is liable to be rejected.

17. The choreographer must have at least 3 years of experience in conducting fashion shows for reputed fashion events/ organizations like FDCI, NIFT, Bengaluru Fashion Week, LIFW, etc. The proof for the same may be submitted along with the documents.

18. The service agreement has to be signed on the legal bond paper of Rs.200/- purchased by the service provider and it will be valid till the event's successful completion.

19. The full & final payment shall be made on the successful completion of the show, on the production of a satisfaction certificate from the Co-Ordinator's of the FD & KD departments. No advance payment will be made.

20. The bill will be settled within 21 days from the date of submission of the bills.

21. The service provider shall ensure that himself/ herself or his authorized representative is available for proper handing over the event at any place NIFT is holding the show. The service provider should depute skilled operators to operate the equipment and should support models (preferable students from NIFT) for their design.

22. NIFT reserves the right to accept or reject any or all the offers either fully or partially without assigning any reasons and is not bound to accept the lowest bid since due weightage shall be given to several factors besides the commercial bid.

23. The specification of items required as per the Annexure/ Schedule and the evaluation of the bid will be based on the total bid value. The rate quoted should be inclusive of all taxes and duties including GST. The rates quoted should be based on free delivery to the consignee.

24. The rates quoted should be on a FIRM & FIXED basis.

25. Price may be quoted on a unit basis for the items and other requirements as per the annexure. Delivery is required in Bengaluru (venue and date will be shared with the identified service provider).

26. All the required items and equipment required on **31st May 2024 at the venue**. The stage setup will be done on the same day of the event.

27. The Work Order shall be issued by NIFT, Bengaluru, and delivery of the items and other requirements/ equipment shall be arranged by the service provider at any place where NIFT is holding the show, in Bengaluru.

28. The Service provider should be registered for GST and Income Tax and should enclose copies of relevant certificates.

29. Firms must indicate in their offers the different taxes and duties which they propose to charge mentioning the present rate(s) thereof. Vague offers like "**duties as applicable**" shall not be considered.

30. In case of any dispute raised by the service provider, a representation will be made only by the authorized representative of the service provider, and the decision of the Director, NIFT – Bengaluru will be binding on the service provider. The jurisdiction of the Court will be Bengaluru.

31. For items mentioned in the schedule and annexure, the bidders must ensure the required quality, material, dimensions & other parameters and quote accordingly.

32. The service provider must visit the NIFT, Campus personally and discuss with CC-FD and CC-KD for all information/requirements and acquire adequate knowledge of the venue and show before submitting the tender document. No additional payment will be entertained apart from the quote.
