Notice for payment of fees for the semester January-June, 2012

(Ref.: HO letter no. 1400/Head – AA/Fee structure/2010 dated 5th January, 2012 from Head –AA(HO))

For Semester II, IV, VI & VIII students will have to pay the following fees. **The last date for depositing the fee is 27th January, 2012 (As per academic calendar).** Fee with a late fine of Rs. 100/- per day can be deposited **till 10th February, 2012.** Due to non payment of semester fee by **10th February, 2012**, the name of the student will be struck off from the rolls of the institute without any further notice.

NOTES:

1. The student repeating this semester will be required to pay the re-registration fee of ₹ 5,000/- per absenting semester as well as non-refundable annual charges towards Library and Student Development & Medi-claim fee over and the above mentioned amount.
2. The NRI Students will have to pay other than Tuition Fees i.e. all other fees will be as per B (2 & 3), C, D and E (whichever applicable).
3. For all students, Internet fee of Rs. 1,000/- is compulsory and Girl's Hostel students have to pay Internet fees of Rs. 2,000/- per semester. Transportation fee of Rs. 1,500/- for all other students are compulsory. Mess Fee and other Transportation Fees payable are as per applicable.
4. Students who have been awarded NIFT – Means cum Merit Scheme for 2011-12, the concerned students are requested to follow the instructions issued in the letter of said scheme and pay tuition fees accordingly. They should also attached the true copy of subsidy sanction with challan of fee to be paid. Other fees/charges need to be paid as per rule.
5. Fees shall be paid in full. The students shall not be allowed to join the course if fees are not paid by the due date. Semester fees once deposited shall not be refunded. Any delay in payment of fees without prior official permission would result in debarring of the student from attending classes. One has to pay the fees before the last dates irrespective of their non being on the campus due to craft cluster/ documentation visits, internship, industry visits, etc. academic assignments. **The fees will be accepted in the form of Demand Draft or Pay order only in favour of NIFT payable at Ahmedabad, Gujarat.**
6. **The last date for depositing the fees is 27th January, 2012 (as per the Academic Calendar).** Fee with a late fine of ₹ 100/- per day can be deposited till 10th February, 2012. Non payment after this date the name of the student will be struck from the institute rolls without any further notice. After striking off of the name of the student from the NIFT rolls due to non payment of fee with or without fine, if the student still wants to continue studies in NIFT, the student would have to pay a re-registration fee of Rs. 5,000/- over and above the semester fee within the next fifteen calendar days after the notified last day for depositing fee with fine. The student will be allowed back into class only after receipt of full fee. It will
