Duly filled and signed application along enclosing therewith prescribed fees and attested relevant documents should be addressed to signed along with the requisite fee of **Rs. 500/-** (for all categories) should send their hard copy of the application(s) addressed to **The Director**, **National Institute of Fashion Technology**, **NIFT Campus, Mangattuparamba, Dharmasala, Kannur – 670562** and superscribed with "Application for the post of (Name of the post applied for) "\_\_\_\_\_\_ on contract" on the envelope. The last date of receipt of hard copy of the application is **24/01/2019**, **Monday** till end of office hours.

- b) Attested copies of all uploaded certificates and testimonials in proof of age/ educational qualifications/ caste / experience etc. should be attached with the hard copy of the application as stated above.
- c) The demand draft should not be tagged or stapled but should be clipped or pined is separate cover at the top of the hard copy of the application form to avoid the mutilation of Demand Draft. Also write your name and your address at the back side of the demand draft before despatching.
- d) Those candidates who are employed in Govt. /Semi Govt. /Autonomous Bodies etc. should send their hard copy of applications through Proper Channel. However, they may send an advance copy of their application along with other attested certificates and testimonials to the above address so as to reach on or before the schedule date.
- e) The date and venue of the interview shall be informed later on website and will be intimated the short listed candidates only through their registered email.
- f) The posts are to be filled up on long term contract basis initially for a period of 5 years.

- h) No TA/DA shall be payable to any of the candidate for attending the screening process.
- i) The Short listed candidates for the above mentioned post will have to appear for the Screening process will include written test and skill test, which will be conducted at NIFT Kannur campus at Dharmasala.

- 2. The maximum age will be 5 years less than the retirement age of regular employees. However, the maximum age would be at par with the Retirement age at NIFT.
- 3. Age limit shall be considered as on 01.01.2019 for the purpose of calculation.
- 4. The appointment of **Female Hostel Warden** would be on **full time residential basis**.
- 5. Incomplete and Unsigned applications are summarily rejected.

- 6. Applications received without fee, photograph, certified copies of required certificates such as educational qualifications, castes / community etc., and those received after the last date for receipt of application, will summarily be rejected without any communication to the candidate.
