## **PREAMBLE / INTRODUCTION**

National Institute of Fashion Technology (NIFT) is a premier educational institution set up under an Act of Parliament and functioning under the aegis of the Ministry of Textiles, Govt. of India. The Bengaluru Centre has been set up since August 1997 with Under Graduate and Post Graduate programmes.

Note: 1. NIFT Donations are exempted u/s 80 (G) of Income Tax Act.

2. Being registered with DSIR, NIFT is entitled for Custom/ Central Excise duty exemption

## **TENDER NOTICE:**

NIFT invites sealed Tenders under **Two Bid systems** for providing “CAMC for Diesel Generator Set” to NIFT Bengaluru as per the specification mentioned in the price bid. The tender bids duly-filled in all respects enclosing necessary documents may be addressed to **The Director, NIFT, HSR Layout, Bengaluru – 560 102** so as to reach on or before **11.00 AM, 04<sup>th</sup> December, 2020** or the tender may be dropped in Tender Box.

## **MODE OF SUBMISSION**

A. Tenders should be addressed to the Director, NIFT Bengaluru by designation only.

B. Tender should be submitted in the following **two separate covers** :

i) **Technical Bid**      ii) **Price Bid**

The above mentioned two sealed envelopes should bear the name and complete postal address of the bidder. Sealed envelopes containing Technical Bid and Price Bid should be placed in a bigger envelop super-scribed as **providing “AMC for Diesel Generator Set”**. This bigger envelop, bearing the name & complete postal address of the bidder and contact number.

Tenderers furnishing Technical Bid and Price Bid in a single cover / same cover will be summarily rejected.

Tenders received after the due date and time, for any reasons, it will not be considered, and the Director, NIFT Bengaluru will not be liable or responsible for the same.

**Technical Qualifying Criteria:**

1. The Firm should have all the necessary registrations of the Govt. under the Shops and Establishment Act, PAN Number, GST Registration for Karnataka, CST, Service Tax, Sale Tax / Exercise Duty (If applicable) etc. (enclose copy of the documents)
2. The cost of tender document is **Rs.236/-** (inclusive of 18% GST and Non – refundable). The tender document can be obtained by paying the fees through Cash or Demand Draft/Banker's Cheque drawn in favour of NIFT payable at Bengaluru. The Tender Document is not transferable to any other bidder.

4. The Technical Bid should contain Earnest Money Deposit (EMD) of **Rs.10,000/-** in the form of Demand Draft / Pay Order in favour of NIFT, payable at Bengaluru. This EMD will not bear any interest.
5. If exemption from EMD, the supporting documents to be attached (NSIC / MSME).
6. Firm should enclose Balance Sheet / IT Return for the latest year (two years).
7. Company/ Firm should have authorized certificate from Original Equipment Manufacturer(OEM) of Diesel Generator(DG) to service Greaves make DG set (or) minimum 3 years' experience in servicing of Greaves DG sets with same nature of work and enclose self-attested copy of the work order or work completion certificate issued by the Government organisation/ PSU/ any reputed organisations for having carried out same nature of work along with other self-attested copies of OEM issued Authorization Certificate to carryout same nature of work and other documents as mentioned in Technical Qualifying Criteria should be enclosed in the Technical Bid

**SCOPE OF WORK:**

- a. Monthly one service(annually 12 service) and work has to be carried out as recommended by Original Equipment Manufacturer(OEM) of DG set.
- b. "B" check service has to be carried out half yearly once along with materials.
- c. No limitations for breakdown service visit and no additional payment for additional service visit.
- d. Above AMC cover 125KVA and 250KVA DG set engine, alternator and respective remote control panel, AMF panel including all the spares as per terms and conditions.
- e. Work has to be carried out as per schedule of work mentioned in the Price Bid.
- f. During the service, it has to be ensured the tightness of the control & power cable and batteries terminals of DG set side.

### **General Terms and Conditions**

- a. Work mentioned in the Schedule –II has to be carried out only under unserviceable condition of the radiator and payment will be made after completion of the work.
- b. NIFT Bengaluru reserves the right drop any part of the work/item and AMC contractor should carry out the work as per the quoted rate per item/work.
- c. Monthly one service (annually 12 service) and work has to be carried out as recommended by Original Equipment Manufacturer (OEM) of DG set.
- d. "B" check service has to be carried out half yearly once along with materials.
- e. No limitations for breakdown service visit and no additional payment for additional service visit.
- f. Above AMC cover 125KVA and 250KVA DG set engine, alternator and respective remote control panel, AMF panel including all the spares as per terms and conditions.
- g. Work has to be carried out as per schedule of work mentioned in the Price Bid.
- h. During the service, it has to be ensured the tightness of the control & power cable and batteries terminals of DG set side.

### **TENDER TERMS & CONDITIONS:**

1. Please read the terms & conditions carefully before filling up the document.
2. Incomplete tender documents will be summarily rejected.
3. Conditional tender may not be accepted or the condition(s) may not to be considered.
4. The Contract shall be initially for one year and may be extended / renewed for further periods subject to satisfactory service. Maximum three years including first year.
5. The agency/tenderer should have at least three years of relevant experience in executing/rendering such services.
6. The contract of AMC for Diesel Generator Set shall be commercial contract and between NIFT & the successful tenderer. There shall be no employer-employee relationship between NIFT and the Tenderer or the staff / personnel deputed by the said contractor.
7. Tender(s) submitted beyond the scheduled last date & time and without the required Annexure(s) & documents will not be considered. Tenders received after the specified date and time, due to whatever reason including postal delays, if any, will not be considered.
8. Tender shall be submitted in official tender form only and should not be altered. If submitted in any other form or altered the same shall be summarily rejected.
9. No tenderer shall submit more than one tender document.
10. All tenderer are required to submit Earnest Money Deposit (EMD) of **Rs.10,000/- (Rupees Ten Thousand only)** (refundable) in the form of Demand Draft (DD should be drawn after the date of this notification). DD in favour of NIFT Bengaluru payable at Bengaluru. No interest shall be paid on the EMD and it will be returned after finalization of the tender; however, the EMD of the successful bidder will remain with NIFT and will be forfeited in the following events:
  - a. If information declared/document submitted found false/fake/forged
  - b. If the selected/successful bidder does not accept the W.O. or unable to provide services
  - c. If the bidder withdraws his bid/quote
11. The successful bidder needs to **deposit 10%** (Ten Percent) of the total Contract Value as Performance Security Deposit by Demand Draft, in favouring NIFT Bengaluru or by Bank Guarantee which will be refunded, without any interest after 3 months of completion of the contract with deduction(s), if any and as applicable.
12. The minimum annual turnover for past two years should not be less than **Rs.20 Lakhs** per year which should be substantiated by Audit report.
13. DD of EMD to be submitted along with the Technical Bid only and NOT with the Price Bid. All bidders should mention their company name and tender No. at the back of the DD(s).
14. If the Technical and Price bids are submitted together in the same cover, the same will be rejected.

15. No overwriting, correction, insertion shall be permitted in any part of the tender unless duly countersigned by the tenderer. The tender should be filled in and submitted in strict accordance with the instructions laid down herein; otherwise, the tender is liable to be rejected.
16. The quote/rates should be valid at least 3 months from the date of opening of the tender; however, in case of the successful tenderer the quote/rate shall be valid for the entire period of contract and during extended period. Prevailing statutory rates (S. Tax, GST etc.) as revised by the Govt. from time to time will be considered.
17. Non-compliance of any terms and conditions enumerated in the contract shall be treated as breach of contract.
18. The contractors should adhere to the statutory regulations viz., Minimum Wages Act, Shop and Commercial Establishment Act, ESI Scheme and any other regulation covering labour contract.
19. Payment will be made half yearly once after submission of bills in duplicate along with service reports certified by NIFT Authority for completion of work, delivery challan acknowledged by NIFT for supply of materials for carried out the service including materials required for oil("B" check) service. The bills should be accompanied by same certificate as NIFT may prescribe from time to time. Income Tax (TDS) as applicable at current prevailing rate will be deducted at source. Payment will be made within 30 days after submission of the bill. However, in the event that there is any query, objection or dispute with regard to bill or a part thereof, the contractor shall not be entitled to any interest to be paid for late payment till such time that the query, objection or dispute is resolved. The contractor will be entitled for payment of amount as agreed by NIFT per year after deducting TDS as per the existing rates.
20. In the event of non-satisfactory service or any default, payment may be deducted as penalty as deemed fit which will be decided by the NIFT authority and decision of NIFT in this regard shall be final & binding on the agency/service provider.
21. Even after qualifying in the technical bid, the price bid may be rejected if found not in order. Merely qualifying in the technical bid does not ensure acceptance of the price bid.
22. In case of L-1 is more than one, the selection criteria [viz. the past performance, turnover, etc.] would be at the discretion of NIFT. The decision of NIFT, in this regard and for selection of successful bidder in such a situation, will be final in all respect and will be binding on all the tenderers.
23. NIFT is not bound to issue work order to the agency being the 'L-1' bidder; weightage/preference will also be given to the other factors, viz. previous experience, quality of service, number of client, etc. to select the agency to award the work and the decision of NIFT in this regard and for selection of successful bidder will be final in all respect and will be binding on all the tenderers.
24. The Tenderer shall abide by the Rules and Regulations of NIFT, as may be enforced from time to time. The successful agency will have to work in close co-operation with others at the site.
25. NIFT shall in no way be responsible for default with regard to statutory obligation, if any, related to the manpower deputed by the successful agency/firm to render the said service. It will be the sole responsibility of the successful bidder. Deputing Child Labour to render the said service is strictly prohibited.
26. The personnel to be deputed to render the said service must bear good moral character with decent personality, well-disciplined and sincere. If, any time, any of the personnel are found to be guilty of misconduct in any manner, the tenderer shall replace that person forthwith.
27. As per the NIFT policy, payments and receipts to Government and Semi Government Agencies would be rounded off to the nearer higher rupee and in other cases the rounding off will be to nearest i.e., paisa 50 or above will be rounded off to the near higher rupee and paisa less than 50 will be ignored.
28. The successful tenderer shall be solely responsible for injuries and accidents, if any due to executing the said Service to persons deputed by him at NIFT Bengaluru.

29. In the event of injury, illness or mishap to any personnel/manpower deputed by the successful bidder to render the said service, NIFT, Bengaluru will not be liable to pay any compensation.
30. The Tenderer will indemnify NIFT in case of any damage or liability, which may arise on account of action of any reason by the successful tenderer.
31. The Tenderer shall not engage any Sub-A Control Service or Sub –Contractor whatsoever for rendering AMC of DG Set at NIFT Bengaluru.
32. It is preferred that the tenderer should have an operating office in Bengaluru.
33. Smoking is strictly prohibited at workplace.
34. The agreement will be valid for a period of one year subject to review at the discretion of NIFT authorities at mutually agreed terms and conditions.
35. Service engineers to visit the site once in a month totaling to twelve visits per year. No limitations for number of visits to attend breakdown calls and no additional payment will be paid in this regard over and above the quoted price.
36. Service engineer will carry scheduled preventative maintenance checks on Diesel Generating Sets as per the standard check list.
37. NIFT will not provide any mode of transport in respect of manpower or any items/materials required for the service.
38. NIFT reserves the right to terminate the contract at any point of time at its sole discretion due to non-satisfactory service or violation of Terms & Conditions or due to any applicable reason and NIFT's decision in this regard shall be final and binding.
39. The Bidder shall quote the rates in figures as well as in words. If there is any mismatch, either the lower amount will be considered or the quotation may not be accepted as may be decided by NIFT authority and decision of NIFT in this regard shall be final & binding.
40. The rate offered must be filled in the proforma of the tender form. If, any correction / over writing - should be initialed by the tenderer in the price bid attached with this document.
41. It is strongly recommended that the tenderer should inspect the site any time during working hours on any working day with prior appointment (Mr. Arul, Estate Engineer Tel. 9894744586) before submission of bid; no extra shall be payable for lack of knowledge of the site conditions and constraints, if any.
42. Any query/clarification with respect to the tender (T&Cs, etc.) may get cleared prior to submission of bid; concerned NIFT official(s) may be contacted in this regard in between 10:00 am to 5:00 pm on any working day with prior appointment (Mr. Arul, Estate Engineer Mob. 9894744586). However, NIFT will not entertain/clarify any such query during post bid.
43. Care must be taken so that no furniture, fixture, fittings are damaged while carrying out the work by the contractor. Any damage done to the same will have to be repaired /replaced by the contractor and on termination of the contract the contractor will hand over all the supplied equipment/articles if any in good condition back to NIFT.
44. All disputes are subject to Bengaluru Jurisdiction only.
45. NIFT reserves the right to accept or reject any or all the tenders in part or whole or may cancel the tender at its sole discretion without assigning any reason whatsoever and decision of NIFT in this regard shall be final and binding on all the tenderers. No further correspondence in this regard will be entertained.
46. The tenderer should not be black listed by any department of the central or state government or PSU or any other organization. The supplier must give an undertaking in this regard.
47. If any call received for any breakdown service, the contractor should respond within 24 hours.
48. Works have to be carried out by qualified and experienced person in the same nature of work.
49. The contractor has to carry out the work by following local bylaw.
50. NIFT Bengaluru reserves the right to drop any part of the works/items and AMC contractor should carry out the work as per NIFT work order and respective quoted rates per item/work.

51. The contractor should provide all the safety equipment to their employee for carrying out the work.
52. In case of any accident (or) due to negligence (or) unsafe work that require immediate medical attention, the contractor is wholly responsible.
53. Safety measures should be strictly followed during execution of work.
54. Fully comprehensive AMC shall be covered all the spares, manpower, transport, "B" check service with required materials etc. And for minor comprehensive AMC shall be covered all the spares value upto Rs.15,000/- and two "B" service with all required materials as per schedule mentioned in the price bid.
55. Force Majeure clause is applicable as per Government guidelines.
56. Work mentioned in the schedule of rates for replacement of radiator will be applicable if work awarded for minor comprehensive AMC and replacement of radiator for 250KVA DG set has to be carried out only under unserviceable condition of the radiator (after approval of the NIFT Authority and in this regard separate work order will be issued based on rate quoted in the tender).
57. The contractor should hand over the DG set in working condition at the end of completion of AMC period. If any defect noticed and it should be rectified the same without any additional cost as per AMC terms and conditions.
58. Security Deposit will be refunded without any interest after successful completion of AMC period and after adjustment of due if any.
59. Supply of spares /materials should be as recommended by the OEM. If any damage/s due to negligence in the work and same has to be rectified by the contractor without any additional cost.
60. AMC contractor should provide genuine materials as recommended by the OEM.
61. Work mentioned in the Schedule –II has to be carried out only under unserviceable condition of the radiator and payment will be made after completion of the work.
62. NIFT Bengaluru reserves the right drop any part of the work/item and AMC contractor should carry out the work as per the quoted rate per item/work.
63. Priority will be given to the authorized service agencies/contractors

### **PENALTY**

While all contractual obligations will be strictly enforced, deduction will be made for poor service like.

- a) Person sent by the agency for servicing not bringing the required items/spares or required Quantity.
- b) The service personnel refusing to perform duty assigned in respect of DG Set.
- c) "Service not carrying out within specified period as recommended by OEM"
- d) Deduction will be made for poor service like not carrying out monthly services, deficiency in the quality of items/spares used, and misbehavior of the staff deployed for supply and services.
- e) The penalty will be levied on the basis of work assessment by NIFT. The decision of NIFT will be final and binding in this regard. The penalty will be 2%-5% of work claimed subject to maximum penalty of 25% of the Half yearly bill.
- F) Breach of contract terms and conditions or earlier period termination of contract, Security Deposit will be forfeited.
- G) EMD or Security Deposit will be forfeited and tenderer will be disqualified from participating in any future tender of the NIFT if tenderer violates any of the conditions prescribed in the Tender Document or if the successful tenderer fails to enter into an agreement in non-judicial stamp paper or in the event of refusal to carryout work on any grounds.
- H) Any breakdown has to be attend immediately and if any breakdown not rectified within the reasonable/specified time period and same will be rectified through other contractor/agency and amount spent will be deducted from the AMC contractor due/Security Deposit.

### **DURATION:**

1. The agreement will be valid for a period of one year subject to review at the discretion of NIFT authorities at mutually agreed terms and conditions.
2. The contract once awarded can be terminated by either party after giving two month notice to the other party. Nevertheless, NIFT may terminate the contract without any notice in case the contractor commits breach of any of the terms of the contract. NIFT's decision that breach has occurred will be final and shall be accepted without demur by the contractor.
3. Contractor shall be required to submit an application for continuance of the contract before three months of expiry of the contract if so desired and if such extension is within the scope of the terms of contract.
4. If the contractor does not receive the extension letter before expiry of the contract in spite of his request the contract shall be automatically treated as expired and no extension shall be granted in any circumstances.
5. The CAMC service contract shall remain valid for a period of one year from the date of award of the contract. However a renewal of the contract on an annual basis may be considered by the competent authority, i.e. Director, NIFT, Bengaluru, based on satisfactory performance of the contractor at the same rates. Such renewals can be done only for a maximum period of three years including the first year of contract i.e. renewal can be done for a maximum of two times only.
