#### 1. INTRODUCTION:

#### **TERMS AND CONDITIONS**

- 1. The scrap items to be auctioned "as in where condition basis".
- 2. The obsolete items viz: Machineries of this Institute will be sold.
- 3. The tenderer should quote the rate for all the items/materials. Partial quoting will be strictly rejected.
- 4. A Demand Draft of Rs.25,000/- (Rupees Twenty five thousand only) is required to be deposited as Earnest Money Deposit (EMD) in favour of NIFT, Payable at Bangalore. The same is should be enclosed along with technical bid cover.
- 5. Tender received without EMD will not be considered.
- 6. EMD amount will not carry any interest.
- 7. The bidder is requested to see all the items before quoting the price on any working day between 9.30 am to 4.30 pm.
- 8. If the bid document is not in the NIFT Format, the same will be rejected. They should not be altered.
- 9. The highest quote (H1) amount will be considered.
- 10. GST 18% will be applicable over the H1 quoted rate.
- 11. The bidders should quote their bid price, as per the NIFT format, in a sealed cover addressed to "The Director, NIFT, NIFT, Campus, No. 21, 16th Cross, 27th Main, HSR Layout, Bengaluru 560 102".
- 12. The bidders should quote the price for the lot. Quotes for selected items will not be considered and liable for rejection of the tender.
