PREAMBLE / INTRODUCTION

National Institute of Fashion Technology (NIFT) was set up by the Ministry of Textiles, Government of India in 1986 which has been accorded statutory status under the Act of Parliament in 2006 (NIFT Act 2006) for the promotion and development of education and research in the field of Fashion Technology. NIFT provides fashion business education across the country through its network of 17 centers. It provides four years under graduate (UG) program in Design and Technology, two years post graduate (PG) program in Design, Fashion Management & Fashion Technology and short duration education program to address the specialized needs of professional and students in the field of Fashion. NIFT has its head office at New Delhi with its campuses located at Bengaluru, Bhopal, Bhubaneswar, Chennai, Gandhinagar, Hyderabad, Jodhpur, Kangra, Kannur, Kolkata, Mumbai, New Delhi, Panchkula, Patna, Raibareli, Shillong and Srinagar.

The Bengaluru center has been set up since August, 1997 with Under Graduate and Post Graduate Programmes.

Tender Notice:

NIFT Bengaluru invites sealed Tenders under two Bid systems for Design Collection Show / Choreography, as per the requirement / specification mentioned in the Price Bid. The tender bids duly-filled in all respects enclosing necessary documents may be addressed to The Director, National Institute of Fashion Technology (NIFT), CA Site 21, 16th Cross, 27th Main, Sector 1, HSR Layout, Bengaluru – 560 102 **so as to reach on or before 11:30 am, 09th May 2022** or the tender may be dropped in Tender Box placed at 'A' Block of NIFT, Bengaluru Centre. The Technical bid will be opened on the same day at **11.45 am** in NIFT, in the presence of tenderer who may wish to be present, either by themselves or through their authorized representatives

Technical Qualifying Criteria:

1. NIFT proposes to invite tenders for Choreography for their Graduating **Fashion Show on 10th June 2022**. The tender shall be submitted in two separate sealed envelopes, one for the Technical Bid (as per **annexure 'A & A-I' Page Nos from 1 to 7**) and another one for the Price Bid (as per annexure 'B' – Page No. 8&9) which should be clearly super scribed on the envelopes. Both these sealed covers are to be put in a bigger / outer cover which should also be sealed & duly super scribed as "Choreography for **Design Collection – 2022**"
2. Tender shall be submitted in official tender form only. If submitted in any other form the same shall be summarily rejected. No tenderer shall be issued more than one tender form.
3. **Tender form is free if downloaded from the website <http://www.nift.ac.in/bengaluru/businessopportunities.html>.**
4. No paper shall be detached from the tender document.

5. Tenderer shall enclose a demand draft / pay order on any Nationalized Bank/Scheduled Bank of **Rs.25,000/- in favor of NIFT** payable at Bengaluru as the non-interest bearing Earnest Money Deposit [EMD].
6. Offers received without EMD will be rejected.
7. For exemption of EMD, supporting documents should be attached (copy of MSME/NSIC registration certificate).
8. The name and address of the tenderer shall be clearly written in the space provided and no overwriting, correction, insertion shall be permitted in any part of the tender unless duly countersigned by the tenderer. The tender should be filled in and submitted in strict accordance with the instruction laid down herein: otherwise the tender is liable to be ignored.
9. The tender is liable to be ignored if complete information is not given therein, or if the particulars and data (if any) asked for in the Schedule to the tender are not filled in.
10. NIFT shall in no way be responsible for any default with regard to any statutory obligation and the service provider /vendor/contractor will indemnify NIFT in case of any damage or liability, which may arise on account of action of the firm.
11. **Tenderer must sign along with company seal on each and every page of the tender document as token of the acceptance of the tender conditions.**
12. The Earnest Deposit Money to other than lowest bidders will be returned within two weeks of opening of the tenders.
13. Tender shall be accompanied by the relevant documents including "A - list of organizations where the choreographer has recently provided needs to be enclosed.
14. **The contractor should deposit 3% (as per Covid'19 condition) of the quoted price as Performance Security Deposit by Demand Draft / Bank Guarantee in favor of NIFT, payable at Bengaluru, which will be returned after successful completion of show/event and after adjusting dues, if any.**
15. These rates will be valid for **60 days** from the date of opening of the tender document.
16. No tenderer will be allowed to withdraw the tender rates after opening of the tender (price bid). If any tenderer withdraws the rates the EMD amount deposited by him/her will be forfeited and he/she will be disqualified from participating in any future tender of this Institute.
17. Rates should be offered unconditionally and if rates are submitted with any condition the tender liable to be rejected.
18. **The choreographer must have at least 5 years' experience in conducting fashion shows for reputed fashion events / organizations like FDCI, NIFT, Bengaluru Fashion Week, LIFW, etc. the proof for the same may be submitted along with the documents.**

19. The full & final payment shall be made on the successful completion of the show, on production of satisfaction certificate from the Co-ordinators of FD & KD departments.
20. The bill will be settled within 21 days from the date of submission of the bills.
21. The service provider shall ensure that himself / herself or his authorized representative is available for proper handing over the event at any place NIFT is holding the show.
22. The service agreement to be signed and it will be valid till the event completion.
23. NIFT reserves the right to accept or reject any or all the offers either fully or partially without assigning any reasons and it is not bound to accept the lowest bid since due weightage shall be given to several factors besides the commercial bid.
24. The specification of items required as per Annexure/Schedule and the evaluation of bid will be on the basis of total bid value.
25. The rates quoted should be on FIRM & FIXED basis.
26. Price may be quoted on unit basis for the items and other requirements as per annexure.
27. All the required items and equipments required on **10th June 2022 at the venue**. The stage set up will be done on the same day of the event.
- 28. The Work Order shall be issued by NIFT, Bengaluru and delivery of the items and other requirements / equipment's shall be arranged by the service provider at any place where NIFT is holding the show, in Bengaluru.**
29. They should be registered for GST and Income Tax and should enclose the copies of relevant certificates.
30. For items mentioned above, the bidders must ensure the required quality, material, dimensions & other parameters and quote accordingly.
31. Firms must clearly indicate in their offers the different taxes and duties which they propose to charge mentioning clearly the present rate(s) thereof. Vague offers like "**duties as applicable**" shall not be considered.
32. In case of any dispute raised by the service provider, a representation will be made only by the authorized representative of the service provider and the decision of the Director, NIFT – Bengaluru will be binding on the service provider. The jurisdiction of Court will be Bengaluru.
