- a) NIFT Bengaluru reserves the right to accept / reject any /all tenders in part/full without assigning any reason thereof.
- b) Any Addendum/Corrigendum date extension in respect of above tender shall be updated in our website www.nift.ac.in/bengaluru/tenders only and no separate notification shall be issued in the press/Bidders. Bidders are therefore requested to regularly visit our website to keep themselves updated.
- c) Opening date and time of Price Bid will be notified after evaluation of the Technical Bid to the shortlisted Bidders only.
- d) Tender should be submitted in Two Bid Packet. The Bidders must carefully follow the instructions / read before submit the bids.

Terms and Conditions

While submitting the tender, if any of the prescribed conditions are not fulfilled or incomplete in any form, the tender is liable to be rejected. If any bidder stipulates any condition, such conditional tender is liable to be rejected.

1. Eligibility Criteria:

- a) Contractor/Company should be registered with PDW/CPWD/local Municipal Authority.
- b) Bidder should have a minimum 5 years' experience in **Finishing & Painting work in civil construction** (of which at least ONE shall be Central/Autonomous Bodies/State Government Department/ Organization / Institution/Autonomous body/PSU/Reputed Organization must be supported with work orders)
- c) The Bidder shall not be under a declaration of ineligibility for corrupt or fraudulent practices or blacklisted by any of the Government agencies.
- d) Average Annual Financial turnover for **any 3 years** during the last 05 years, ending 31st March 2022 (i.e. FY: 2017-18, 2018-19, 2019-20, 2020-21&21-22) should be at least **Rs. 3.0 lakhs**.
- e) The Bidder should have successfully completed similar works during last 5 (Five) years ending last day of month previous to one in which applications are invited should be either of the following:-
 - i. Three similar completed works each costing not less than the amount equal to **Rs.3.0 lakhs** each. **OR**
 - ii. Two similar completed works each costing not less than the amount equal to **Rs.4.50 lakhs** each. **OR**
 - iii. One similar completed work costing not less than the amount equal to **Rs.9.0 lakhs**.

Note:- Similar works/ Same nature of work means - Finishing & painting work in Residential building/Housing building complex/Apartments/ Commercial Building (Colleges/Hotels/mall/hospital in civil construction etc.,
(Minimum Turnover figures and limits are as stipulated by CVC in the prequalification criteria of Tender Document vide CVC Office Memorandum No.12-02-1-CTE-6, dated 17th December 2002).

The Firm should have all the necessary Company/Firm registrations of the Govt., PAN Number, GST Registration Certificate and Excise Duty (If applicable) etc. enclose document for proof.

Scope of Work:

- f) The Successful Bidder shall be responsible to complete the works in all respects and satisfactory performance of complete system.
- g) The Successful Bidder shall be responsible to complete the works towards **Providing & Applying internal Painting work at Hostel Buildings & Admin Block -A at NIFT Bengaluru Campus.** at NIFT Bengaluru Campus for internal painting works in hostel buildings Block E&F (G+3) & admin Block-A (ground Floor) or as per direction of building section. Submission of the tender implies that these conditions of tender have been read by the bidders and is aware of the scope of the work and they use only quality materials to be applying as per given makes in Annex.
- h) Work including supplying the painting material as per approved makes /Removing dry OBD/ applying 01 mm putty, 01 coat cement primer, water proofing cement paint, Plastic emulsion on walls & enamel paint on doors, window railing & grills, providing scaffolding, Necessary machine and tools brushes, globs, eye glasses etc., complete requirement for execution of work as mentioned in the terms and conditions are also under the scope of the contractor.

2. **Tender Document Fee:**

The cost of tender document is Rs.590/- (Non - refundable) including 18% of GST. The tender document can be obtained by paying the fees through Demand Draft / Pay Order of any Nationalized Banks / Scheduled Banks drawn in favour of "NIFT payable at Bengaluru". The Tender Document is not transferable to any other bidder.

3. **EARNEST MONEY DEPOSIT (EMD):**

- a) Bidder should pay EMD through RTGS / NEFT for **Rs.20, 000/-** in favour of NIFT, payable at Bengaluru as the non-interest-bearing Earnest Money Deposit.

By paying EMD amount of **Rs.20, 000/-** by way of Demand Draft / Pay Order of any Nationalized Banks/ Scheduled Banks drawn in favour of NIFT and payable at Bengaluru to be deposited in the NIFT, Bengaluru address. Copy of NIFT, Bengaluru EMD payment receipt should be attached along with the Technical Bid.

- b) Successful bidder's EMD will be retained and it will be adjusted in the performance security deposit.
- c) Technical Bid of Tender document without EMD (or) less than the specified amount will be rejected unless any category of Bidder specially exempted by the Government

from the payment of EMD reasons & proof of the same have to enclosed in the Technical Bid.

- d) Cheque or Bank Guarantees will not be accepted towards EMD.
- e) Unsuccessful online EMD payment will not be considered and the tender will be summarily rejected.
- f) The Earnest Money Deposit/Security Deposit will be forfeited if:
 - i. Bidder withdraws his tender or backs out for acceptance within prescribed time.
 - ii. Successful Bidder fails to remit the Security Deposit.
 - iii. Bidder violates any of the condition as specified in the Tender Document.
 - iv. Bidder revises any of the terms quoted, during validity period.
 - v. Work not commenced beyond unacceptable time period as per work order.
- g) REFUND OF EARNEST MONEY DEPOSIT:
The amount will be refunded to unsuccessful Bidder without any interest after completion of the tender process, and after 60 days of defective liability period.

4. **Mode of Submission:**

The prospective Bidders are advised to read carefully the entire tender document and satisfy themselves about the work, site condition, existing network system by visiting the NIFT Campus, C.A. Site No. 21, 16th Cross, 27th Main Road, Sector-1, HSR Layout, Bengaluru – 560 102 on any working day between 10.00 a.m. and 5.00 p.m. before submitting their tenders (No extra charges shall be payable for visiting the NIFT campus in this regard).

Tender should be submitted in the prescribed Tender Document only Tender should be submitted in Two Bid Packet - comprising of (1) Technical Bid and (2) Price Bid should be submitted.

If submitted other than the prescribed Tender Document format the same shall be summarily rejected.

- If Bidder furnishing with Price Bid in the single/same cover of Technical Bid will be summarily rejected.
- The tender will be summarily rejected, if price of the item indicated in the technical bid.
- Technical Bid is not containing the details of EMD (or) EMD in the Price Bid cover will be summarily rejected.
- All the page of tender document should be signed with affix the seal as a token of acceptance.

Tender can be submitted on or before the due date and time specified in the Notice Inviting Tender.

The tender shall be rejected, if any wrong/ false or incorrect information is given in the tender document.

6. List of Technical Bid (Cover – A) Enclosures:

Technical Bid should contain the following documents and details:

- i. Copy of payment receipt issued by NIFT Bengaluru (or) copy of proof for valid online payment transfer to NIFT, Bengaluru account, towards EMD amount of Rs.20,000/-. If Demand Draft (DD), DD in favour of NIFT, payable at Bengaluru.
- ii. Proof of experience (self-attested copies of purchase / work orders and certificates of satisfactory completion obtained from the institution/organization concerned) in same nature of work for the last (05) five years.
- iii. Copy of Registration with PDW/CPWD/local Municipal Authority
- iv. Copy of average Annual Financial turnover for any 3 years during the last 05 years, ending 31st March 2022 (i.e. FY: 2017-18, 2018-19, 2019-20, 2020-21&21-22) should be at least Rs. 3.0 lakhs.
- v. Client List in which same nature of work carried out in Government Department/Organization /Institution/Autonomous Bodies/ PSU/Reputed/Pvt. Organization during last three years.
- vi. Self-attested copy of PAN card.
- vii. Self-attested copy of income tax return filed by agency as mentioned in the eligibility criteria.
- viii. Self-attested copy of GST Registration details.
- ix. Company/proprietor profile.
- x. Duly filled, signed and affix the seal in all the Annexure of tender documents such as under taking, declaration, General information etc.

7. PRICE:

Bidder shall take into account all costs including providing and applying of Painting work at site of NIFT, Bengaluru Campus etc., In this regard no claim for any extra payment for any reason shall be entertained Rate is inclusive of all taxes as applicable. The rates should be indicated clearly both in Figures and in words. If there is variation between the rates in Figures and words, the lower value will be taken for evaluation.

The rate quoted shall be inclusive of Work, supplying the painting material as per approved makes /Removing dry OBD/ putty and 01 coat of cement primer before applying Plastic emulsion paint, Waterproofing cement paints of ceiling or walls, providing scaffolding Necessary machine and tools brushes, globs, eye glasses etc., complete requirement for execution of work as mentioned in the terms and conditions are also under the scope of the contractor.

The price should be quoted in Indian Rupees.

- a) Validity of the rates quoted in the Tender will be up to 3 months from the date of opening of the Tender.
- b) The quantity may increase or decrease or drop of any item, the bidder should supply and execute the work for quoted price in the tender.
- c) No escalation of prices in the quoted rate will be allowed under any circumstances.
- d) Payment will be made based on actual measurement and quantity.
- e) All Taxes & other charges, if any, should be mentioned clearly.

- f) Statutory rates are subject to change and will be considered as may fixed by the Government.
 - g) All statutory obligations under various laws, imposed from time to time will have to be met by the contractor for which no extra payment shall be made. NIFT will no way responsible for any default with regard to statutory obligation, if any.
8. The contractor shall provide any mode of transport in respect of men or material, tools, equipments etc., required for execution of the work.
9. Works shall be executed at NIFT, NIFT Campus, C.A. Site No. 21, 16th Cross, 27th Main Road, Sector-1, HSR Layout, Bengaluru – 560 102.
10. Bidders should provide the details in the Technical Bid such as company profile, details of all work experience/Company Registration proof of PWD/CPWD/Local Municipal Bodies, etc., of quoted works **proposed for providing to NIFT**, copy of the work order for similar kind of work. The tender shall be rejected, if any of the above detail is not provided in the Technical Bid, wrong/ false or incorrect information is given in the tender document.
11. During evaluation of Technical Bid to consider the Tender, If any clarification on quality standards of the proposed items for supply such as painting materials etc., of the required by NIFT, Bengaluru, respective Bidder has to submit relevant documents.
- If required, Bidder has to submit overall satisfactory certificate obtained from Government Department/ PSU/reputed/Autonomous bodies/Pvt. organization where the same proposed Work already Executed etc., and working more than five years.
12. If complete information is not given (or) if the particulars and data are not filled in correctly (or) not as specified in the Tender document and may render the bid non-responsible and liable to be rejected.
13. NIFT Bengaluru reserves the right to cancel the contract, if unacceptable delay in commencement of work and which lead to delay in completion of work within given time period and EMD/Security deposit will be forfeited
14. NIFT Bengaluru also reserves the right to cancel the contract before Execution of work, if the supplied Materials are not found satisfactory/As per proposed Make list without giving any compensation to the contractor.
15. Opening date and time of Price Bid will be notified after evaluation of Technical Bid to the shortlisted Bidders only.
16. Price Bids of technically qualified bidders only will be opened.
17. Even after qualifying in Technical bid, the **Price bid may not be accepted if found not in order**.
18. The bid shall remain valid for 90 days from the date of opening of the Price Bid. Validity beyond 90 days from the date of opening shall be on mutual consent.

19. In case of L-1 is more than one, the selection criteria (viz. the past performance, experience, turnover, etc.) would be at the discretion of NIFT. The decision of NIFT, Bengaluru in this regard and for selection of successful bidder in such situation, will be final in all respect and will be binding on all the Bidders.
20. Lowest bid may not be the only criteria for selection and NIFT is not bound to issue work order to the agency being the 'L-1' bidder; weightage/ preference will also be given to the other factors such as in Price Bid filled detail is not in order, any difference of technical details given by the Bidder in the Technical Bid and price Bid etc., and the decision of NIFT in this regard and for selection of successful bidder will be final in all respect and will be binding on all the Bidders.
21. The said Providing & Applying internal painting works should be completed within 30 Days from the date of receiving of Work Order failing which a penalty @0.1% of the order value per day will be imposed subject to a maximum of 10% of the Order Value. However, delay in Execution due to any applicable/ unforeseen reason, viz. natural calamity, non-availability of site, etc., may be considered as may be decided by NIFT Authority. Beyond 45 days of delay Security deposit will be forfeited and NIFT, Bengaluru would be free to award remaining work to other agency at the cost of Contractor.
22. The Committee constituted by the Director, NIFT, Bengaluru shall have the right to verify the particular furnished by bidder. Those technically qualified bids will only be considered for price evaluation (Price Bid). **Price should not be quoted with Technical bid; otherwise the tender will be rejected** without any correspondence. Decision of the Director, NIFT Bengaluru on the eligibility for qualifying technical bids shall be final and no representation shall be considered in this regard.
23. NIFT reserves the right to change the quantity/drop any item or part thereof/change in the scope of work and the bidder shall have to supply the items and execute the work at the same Rate per unit as mentioned in their Price bid.
24. Work will be award to the successful contractor based on More than 5 Year Experience/Registered with CPWD/PWD/Local Municipal Bodies/ Annual Turnover mentioned in the Technical Bid
25. Work awarded contractor should depute only competent and experienced staffs in the same nature work to carry out the work.
26. The contractor shall depute only competent and experienced staff in the same nature work to attend the defect/Rectification, if any, during warranty period.
27. The Director, NIFT Bengaluru reserves the right to accept the whole tender or any part thereof or reject all the tenders, in the interest of the NIFT so require, without assigning any reasons whatsoever and to waive any minor discrepancy in the tenders received.
28. Any query/ clarification with respect to the tender (Terms and conditions, specification(s), etc.) contact Concerned NIFT Bengaluru official during working day between 10.00 a.m. and 5.00 p.m. or instruction of Engineer In charge and get cleared prior to submission of tender. NIFT will not entertain or clarify any such query during post bid.

29. Security Deposit:

The successful bidder needs to deposit Security Money of 3% of the Work Order value through Demand Draft of any Nationalized Banks/ Scheduled Banks drawn in favour of "NIFT" payable at Bengaluru within Seven days from the day of receipt of the work order. Security Deposit will be refunded/ returned, without any interest, after completion of defect liability period of 01 year from the date of completion of work and deduction, if any and as applicable. Performance Security Deposit may be furnished in the form of an Account Payee Demand Draft, Fixed Deposit Receipt from a Commercial Bank, Bank Guarantee from a Commercial bank in on NIFT acceptable form. The whole amount of the Performance Security Deposit shall be liable to be forfeited in case of breach of any of the terms agreed upon by the contractor.

Refund of Security Deposit will be after completion of the contract period and defect liability period of 60 days beyond the contract period.

30. The material shall be inspected on receipt at site i.e. NIFT, Bengaluru. If any of the material is not in order / defective (or) specification as per the work order (or) material is not suitable, the contractor should replace the material without any additional cost and the contractor shall be responsible for any damage during the transit of goods.

31. If any defective/deviation in the work during execution, the contractor should rectify the same without any additional cost.

32. Payment Terms:

- i. Payment will be released against original invoice after verification of the work and certification of satisfactory completion of the work by the respective NIFT Authority.
- ii. No interim payment will be made on the delivery of the equipments.
- iii. Statutory recoveries (TDS, GST etc.) if applicable will be deducted from the invoice amount as per Rules.
- iv. No payment shall be made in advance. The payment shall be made after completion of works and on the basis of certification by the concerned NIFT Official(s). TDS etc., if any and as applicable, will be deducted during payment.
- v. Payment will be made based on actual measurement quantity on due certification of work by Building Section.

33. The contractor should provide all the safety equipments and tools, testing equipments etc., required to carry out the work.

34. It is sole responsible of the contractor to ensure the safety of the user and if there is any loss to the Institute on account of dishonesty, and or due to any lapse on the part of the contractor.

35. In case of any accident (or) damage due to negligence or unsafe work that require immediate medical attention, the contractor is wholly responsible.

36. NIFT shall not be responsibility for death/injury or accident to the contractor's employee which may arise / arising out of and in the course of their duties.

37. Force majeure clause applicable as per Government norms.

38. Any dispute arises, decision of the Director, NIFT Bengaluru is final authority for settlement of dispute.

39. In the event of any dispute the legal matter shall be subjected to the jurisdiction of Bengaluru Court only.

1st quality acrylic distemper having VOC content less than 50 gms/litre of approved brand and manufacture shall be used. The acrylic distemper shall be diluted with water or any other prescribed thinner in a manner recommended by the manufacturer. Only sufficient quantity of distemper required for day's work shall be prepared.

The distemper shall be brought by the contractor in sealed tins in sufficient quantities at a time to suffice for a fortnight's work, and the same shall be kept in the joint custody of the contractor and the Engineer-in-Charge. The empty tins shall not be removed from the site of work, till this item of work has been completed and passed by the Engineer-in-Charge.

13.19A.2 Preparation of the Surface

13.19A.2.2 In the case of old work, all loose pieces and scales shall be removed by sand papering. The surface shall be cleaned of all grease, dirt etc.

Pitting in plaster shall be made good with plaster of Paris mixed with the colour to be used. The surface shall then be rubbed down again with a fine grade sand paper and made smooth. A coat of the distemper shall be applied over the patches. The patched surface shall be allowed to dry thoroughly before the regular coat of distemper is applied.
