3. Time of completion 15 days from the date of issue work order.
4. Work has to be carried out as per CPWD specification/norms and instruction of NIFT Engineering department.
5. Payment will be made as per actual work done & Site measurements, BOQ quantity may increase or decrease as per certain requirements.
6. Payment will be made after satisfactory completion of work and submission of invoice along with duly certified by the NIFT official.
7. The successful contractor will have to deposit 3% of total work awarded value as performance security deposit by DD or Bank Guarantee in the favor of "NIFT" Payable at Bengaluru within a week time period.
8. The Warranty/Defect liability period after the completion of work will be 06 months from the date of completion and handing over of the work.
9. Warranty will be inclusive of materials and workmanship. It is the responsibility of the contractor to rectify the defect, if any, during defect, Liability, Period, within the stipulated period, at free of cost.
10. Performance Security Deposit amount will be released after 60 days completion of defect liability period of 06 months.
