2. Work should be completed on time bound and urgent basis.
3. Work has to be carried out as per CPWD specification/norms and instruction of NIFT Engineering department.
4. Payment will be made as per actual work done. BOQ quantity may decrease as per actuals, increase is permissible up to 5% - exceeding needs additional administrative approval.
5. Payment will be made after satisfactory completion of work and submission of invoice along with duly certified by the NIFT official.
6. The successful bidder/service provider should furnish a performance security deposit in the form of demand draft for a sum of Rs.10,000/- in favour of NIFT Payable at Bengaluru within a day from the date of order.
7. Performance Security Deposit amount will be released after 60 days completion of work.
8. If any unacceptable delay in commencement of work and consequently delay in completion of work within time period, NIFT, Bengaluru rights to cancel the work order without assigning any reasons whatsoever and assign some other contractor.
9. The contractor shall be liable for their wages etc. and all other dues which the Contractor is liable to pay under various labour regulations and other statutory provisions.
10. Work should be carried out as per local by laws.
