The students are required to pay the applicable fee as per the schedule mentioned below and to note the NIFT rules on non-payment and re-registration.

1. Last date of depositing the fees for July-December, 2025 is **18th September, 2025**. Fee with a late fine of Rs. 100/- per day can be deposited till **3rd October, 2025**.
2. Last date of depositing the fees for the session January-June, 2026 is **16th February 2026**. Fee with a late fine of Rs. 100/- per day can be deposited till **2nd March, 2026**.
3. The name of the student will be struck from the institute rolls without any further notice in case of non-payment of fee after the specified date and a re-admission fee of Rs. 10,000/- + 18% GST = Rs.1800/- = Total Rs. 11,800/- will be levied.
4. Students rejoining to repeat the semester and those rejoining after availing Leave of Absence are requested to contact Academic Affairs Department of NIFT Bhubaneswar before the commencement of the session to complete the formalities. Repeat students will be required to pay the re-registration fee of Rs. 10,000/- + 18% GST = Rs.1800/- = **Total Rs.11,800/-** per absented semester as well as non-refundable annual charges towards Library and Student Development, Medi-claim & Exam fee over and above mentioned amount.

5. **The Hostel Fee for the students will be intimated in a separate circular.**
6. **All the students are advised to pay their fee through their CMS log in ID using finance module.**
7. **The student must send the copy of the transaction within 03 working days with details of UTR No, Date of Transactions, student details, fees details to *accounts.bhubaneswar@nift.ac.in* as per the attached format (*Annexure-I*)**
