#### Introduction

#### 2. Essential Qualification & Criteria: -

- MBBS Degree from a recognized university or equivalent qualification, recognized by the MCI and registered with the Odisha Council of Medical Registration.
- Preference will be given to those who are enrolled in other PSU's / working in autonomous bodies / Educational Institutes for similar assignment.
- At least ten years' experience in the field is mandatory.
- Retired doctors may also apply.

#### 3. Other terms and Conditions:

The empaneled doctor shall be required to visit NIFT, Bhubaneswar Campus three days in a week for one hour and as and when required for specific assignments. The Scope of work and roles and responsibilities will be as follows:

- Will act as Authorized Medical Attendant of NIFT Bhubaneswar Campus and give prescription to all seeking medical advice.
- Will attend cases of employees on commuted leave and medical / certificate thereof.
- Will examine and verify the medical bills submitted by the officials for OPD/IPD reimbursement.
- Reviewing medical status of students and employees of Bhubaneswar Campus.
- **4. Appointment & Tenure:** The engagement shall be purely on temporary basis for a period of one year which will be extendable maximum up to three years including  $1^{st}$  year. Further extension shall be reviewed at the end of the year on satisfactory performance only.

#### 5. Selection Procedure:

The eligible candidate who quotes the lowest amount per visit will be selected for the post of Doctor at NIFT, Bhubaneswar on retensionship basis.
