National Institute of Fashion Technology, Chennai invites applications for engagement of a Hindi Translator from retired Central Government/Autonomous Bodies/ Central & State Universities (excluding PSU) in the Level of 10 as per 7th CPC on substantive post at the time of retirement to engage on requirement basis as Consultant (Hindi Translator) as per the General Information and the Terms & Condition given as in Annexure – I.

Suitable retired Government officers who are eligible and willing to accept the General Information and the Terms & Conditions at **Annexure I** may send their applications by speed post duly filled Bio-Data as in **Annexure II** along with a copy of the PPO /Pension Card duly self – attested to undersigned within 15 days from the date of advertisement. Selected candidates will require attending interview which will be informed to the applicant suitably. - The persons retired from Central Government/Autonomous Bodies/ Central & State Universities (excluding PSU), who
 had been drawing pay level of Level 10 as per 7th CPC on substantive post at the time of retirement, are eligible for
 engagement as Consultant.
- The candidate should be holding a Degree from any University / Institution recognized / approved by the Central / State
 Government with atleast 10 years of regular service at supervisory level possessing rich experience in English-HindiEnglish Translation on Parliament and Administrative related matters at NIFT.
- Initial engagement of Consultant will be for 6 months or till the post is regularly filled, whichever is earlier. This period
 which may be extended or curtained subject to review at the sole discretion of the Director, NIFT, Chennai. The age of
 the consultant shall not exceed 65 years.
- 4. The Consultants shall be eligible for 08 days leave during the calendar year. This leave will not be carried forward in case the engagement period is extended by NIFT. No payment in lieu of un-utilized leaves will be paid by NIFT at the time of expiry of contract.
- 5. NIFT may terminate the services of Consultant in case he/she is unable to achieve the assigned works within the time-frame or the work assigned to him/her is not satisfactory to NIFT or he/she is found to be lacking in honesty and integrity.
- NIFT shall also reserve the right to terminate the services of Consultant at any time without giving any notice and also
 without assigning any reason. The engagement of consultant will not confer any right on the part of individual for
 permanent appointment to the post.
- 7. The Consultant may be called to the Office on Saturdays, Sundays and other Gazetted Holidays or may be asked to sit late in the office after office hours in case of exigency of work. No extra allowances will be permissible for the same.
- 8. The Consultant shall continue to draw pension and dearness relief on pension if any, during the period of their engagement as Consultant. Their engagement as Consultant shall not be considered as a case of re-employment.
- No TA/DA shall be admissible to the consultant for attending the interview or for taking up the appointment. The Consultant will not be allowed any foreign travel at Government expenses.
- 10. The appointment of Consultant would be on full time basis and he/she will not be permitted to take up any other assignment during the period of consultancy at NIFT, Chennai.
- 11. The consultant will not entitled for any benefits / compensation / absorption of regularization of service at NIFT.
- 12. The engagement of consultant is liable to terminated by either side with notice of not less than 30 days. NIFT, however, reserves the right to terminate the engagement without notice by paying remuneration in lieu thereof.
- 13. If any declaration given or Information furnished by the candidate proves to be false or if the candidate is found to have willfully suppressed any material information, he/she will be liable for removal from engagement service and such other action as Government may deem necessary.
- 14. In compliance to the CVC circular No. 07/05/2021 dated. 03-06-2021 vide para no. 3 (i) Vigilance Clearance Certificate from the employer organization from which the Government official had retired shall be necessarily furnished.

Terms & Conditions:

Some of the salient terms and conditions are given below:

- Allowances: The Consultant shall not be entitled to any allowance such as DA, HRA, Transport allowance, Medical
 reimbursement or any benefits etc., however, if he/she is required to travel within the country on official work, TA/DA as
 admissible to the grade from which he/she retired will be payable only based on the approval of the Director.
- Leave: Consultant shall be entitled for 8 days leave in a calendar year with prior approval. No remuneration for the period
 of absence in excess of the admissible leave will be paid to him/her. Un-availed leave shall neither be carried forward to
 next year nor encashed. Duties performed on Saturday, Sunday or any holiday will not be compensated by grant of
 Compensatory Holiday.
