PREAMBLE / INTRODUCTION

Technical Qualifying Criteria:

1. NIFT Chennai invites tenders for choreography for their Graduating Fashion Show scheduled tentatively on 26th May 2018 at NIFT Auditorium, Chennai. The tender shall be submitted in sealed envelopes, Technical bid (as per annexure 'A' and 'A-1') and financial bid (as per Annexure 'B' and Annexure 'C') which should be clearly super scribed on the envelopes as the case may be. The sealed covers are to be put in a bigger cover which should also be sealed & duly super scribed as "Choreography for Graduation Show - 2018". Tender form without signature of the vendor in each page will be summarily rejected.

2. The Tender forms may be obtained from the NIFT Administrative Department at the above address (Monday to Friday during office hours from 10.00 AM to 5.00 PM). The Tender forms may also be down loaded from the NIFT's web site www.nift.ac.in/chennai.

3. The Tenderer can also download the Tender forms from the web site.

4. Tender shall be submitted in official tender form only. If submitted in any other form the same shall be summarily rejected. No tenderer shall be issued more than one tender form. No paper shall be detached from the tender.

5. The name and address of the tenderer shall be clearly written in the space provided and no overwriting, correction, insertion shall be permitted in any part of the tender unless duly countersigned by the tenderer. The tender should be filled in and submitted in strict accordance with the instruction laid down herein: otherwise the tender is liable to be ignored. 12. The specification of items required as per Annexure/Schedule and the evaluation of bid will be on the basis of eligibility criteria and total bid value. The rates quoted should be inclusive of all taxes and duties . The rates quoted should be on the basis of free delivery of any item to the venue.

13. The rates quoted should be on FIRM & FIXED basis.
