NIFT, Chennai intends to dispose of Computers, Peripherals and other materials “as is where” condition. The terms and conditions for tender is as follows:-

### **Terms & Conditions**

1. Tender shall be submitted in official tender form only. If submitted in any other form the same shall be summarily rejected. No tenderer shall be issued more than one tender form.
2. Tenders received without the prescribed Earnest Money Deposit shall not be considered.
3. The Rate schedule issued with the form of tender listing the dispose of Computers, Peripherals and other materials must not be altered by the tenderer. Any modifications/ alterations of the schedule considered necessary by the tenderer should be in the separate letter accompanying the tender.
4. The name and address of the tenderer shall be clearly written in the space provided and no overwriting, correction, insertion shall be permitted in any part of the tender unless duly countersigned by the tenderer. The tender should be filled in and submitted in strict accordance with the instructions laid down herein, other wise the tender is liable to be rejected.
5. A Demand Draft of Rs. 5,000/- (Rupees five Thousand Only) is required to be deposited as Earnest Money Deposit in favour of National Institute of Fashion Technology, Chennai along with the sealed quotation by way of pay order / Demand Draft.
6. The successful tenderer should deposit the value of the material within 3 days from the date of award of tender.
7. The successful tenderer should clean / remove the scrap material within 2 Days at his own cost from the date of award of the tender.

8. If successful tenderer fail to remove the items within the stipulated time, a penalty @ Rs. 500/- per day shall be levied.
9. The tenderer should quote the rate for all varieties of the scrap materials.
10. The filled in Tender form shall be dropped in a sealed envelope on or before 15.11.2019 at 2.00 pm.
11. The tender forms will be opened at 04.00 pm on 15.11.2019 in the presence of the NIFT officials and Tenderer.
12. The rate should be quoted in Indian Rupees in the rate schedule enclosed along with this terms and condition.
13. The tenderer should signed all the pages of the tender schedule.
14. The award of sale of scrap will be considered based on the highest value quoted for each item.
15. The tenderer should have valid GST registration no.
16. NIFT reserves the right to cancel this tender without assigning any reason thereof.
17. In respect of selection of vendors highest bidder in respect of all items and successful tender will be awarded accordingly.
18. The tenderer is requested to come and visit NIFT campus from 10.00 am to 5.00 pm on any working day to check the items of disposal before quoting for the scrap.
19. **The vendor need to submit a valid and authorized e-waste Certificate alongwith the Tender document.**
