1. The prospective tenderers may satisfy themselves about the requirements by visiting the NIFT, Rajiv Gandhi Salai, Taramani, Chennai – 600 113 on any working day between 10.30 a.m. and 2.30 p.m. before submitting their tenders.

(NIFT Person: Assistant Director).

- 2. The tenders should be submitted in the specified form (Non-transferable) as given in a sealed cover with the name of the contractor written on the inner envelope.
- 3. The tenderers shall enclose copies of the following documents:
 - i) Registration Certificate issued by the registering authority.
 - ii) List of their clients with self-attestation for whom they have been executing similar work for the last 3 years along with copies of work orders and other details.
 - iii) Latest Income Tax Clearance Certificate.
 - iv) Service Tax Registration No. from the Central Excise Dept.
 - v) Any other certificates and documents which the contractor would like to enclose to substantiate his stand in the field as a contractor proven ability.
 - vi) Authentication certificate for service from Blue Star Brand Air Conditioner with same and above capacity.
- 4. While submitting the tender, the Contractor shall deposit an Earnest Money of Rs. 15,000/- by Demand Draft / Pay order drawn in favour of "NIFT, Chennai – 600 113 payable at Chennai" (on any Nationalized Banks), which will be refunded to the unsuccessful tenderers within a month.
- 5. Tenders without EMD and incomplete tenders are liable to be rejected.
- 6. EMD will be liable to be forfeited if the Contractor selected for the work fails to sign the formal agreement or to start the work on the date stipulated in the work order.

- 7. If any relative of the tenderer is an employee of the NIFT the name, designation and relationship of such employee shall be intimated to the Director, NIFT in writing while submitting the tender.
- 8. The EMD remitted will not bear any interest for the period retained by NIFT.
- 9. The tender submitted shall remain valid for 90 days from the date of opening for the purpose of acceptance and award of work. Validity beyond 90 days from the date of opening shall be by mutual consent.
- 10. Last date for receipt of tenders in the office of the NIFT, Chennai 600 113, will be 2.00 p.m. on 17-08-2020. Due to Covid 19 pandemic lockdown, the date and time of tender opening will be informed over mobile and email id. The participants are hereby informed to write the contact No. and Email id over the envelope.
- 11. Before signing the agreement, the successful contractor shall deposit 10% of the annual value of contract (adjusting the EMD) as security deposit, which would be released on expiry/termination of the contract after adjustment of dues, if any. No interest shall be accrued on the deposit.
- 12. The contract is for a period of one year only and it may be extended for a further period of maximum 2 years at the same tendered rate based on the performance of the contractor. The Contractor shall execute an agreement on a non-judicial stamp paper worth Rs.20/- before taking up the contract, agreeing to abide by all the terms and conditions mentioned therein.
- 13. NIFT reserves right to accept or reject any or all the tender without assigning any reason whatsoever.
- 14. In case of any dispute, the disputes will be settled in Chennai Jurisdiction only.

Terms & Conditions

- 1. The firms who are not willing to accept the departmental conditions need not quote and participate in this bidding.
- 2. The tenderer is requested to visit NIFT campus from 10.30 a.m. to 2.30 p.m. on any working day to check the items of disposal before quoting.
- 3. The purpose of the awarding the unit service contract is to ensure and to keep the unit in good working conditions and to work to the optimum efficiency.
- 4. The probable date on which the service to the A.C units will be carried out should be intimated well in advance to the NIFT officers in writing by the AMC firm to whom the AMC is awarded.
- 5. The signature of the Electrical staff or the officer in charge of the maintenance shall be got after the units are serviced.
- 6. If the service on the specified date is not possible it shall be carried on the subsequent day without fail with concurrence of the officer in charge of the maintenance.
- 7. The units should be checked and serviced thoroughly once in a month without fail.
- 8. The air filters should be cleaned whenever necessitated or once in month without fail. The Breakdown calls should be attended to immediately and any delay shall be made good through other local agencies at the cost of the AMC contractor.
- 9. The parts requiring lubrication should be done at periodical intervals with necessary lubricants at no extra costs.
- 10. No advance payment will be made for the service contract.
- 11. The service bills will be issued after the completion of service and due certification by the officer in charge of maintenance.
- 12. All the components should be checked thoroughly to work in perfect conditions and it should be ensured that all the safety devices work perfectly. Checking

vibration and condensate drain, and polishing of the decorative cabinet should be carried out once in two months along with service to the replacement of Air conditioners.

- 13. Since this is a comprehensive service contract spares of all the materials including roof top chiller, Air Handling Units (AHU) along with chiller water pumps (3 phase, 10 HP capacity) including spare pump replacement should be done at no extra cost. All the repairs to all the parts pipe lines & other accessories and switch control panel should be carried out at no extra cost without any delay.
- 14. The defective compressor should not be cut open and repaired; instead the defective compressor should be replaced with factory sealed compressor. The compressor shall be checked for its proper functioning.
- 15. The rates quoted should be inclusive of all Taxes.
- 16. The GST shall be paid separately as per rules in force.
- 17. The amount falls due from the contractor on account of this contract even after recovering from the bills and adjusting the security deposit and any other contract awarded to the contractor, the amount is liable to be recovered under the provision of the Revenue Recovery Act.
- 18. The refrigerant and cooling lines should be checked for leaks and proper insulation provided periodically.
- 19. The strength of base frame, platform and also proper tightness of the fixing bolt units shall be checked periodically.
- 20. The contractor should handover all the machines in good working condition and any disputes the contractors responsible to rectify the same and handover to next contractor after completion of the contract period.
- 21. The filters where dust accumulate will be cleaned and maintained as dust free area.

- 22. All the electrical contact points and connections should be checked and minor adjustments made if found necessary. The replacements for the outgoing electrical switches and cables from the A.C. units should be done without any extra charge.
- 23. The A.C. units shall be over hauled as and when required.
- 24. No advance payment on any portion of service will be made under any circumstances.
- 25. Comprehensive AMC including AHU, compressor, belt, MCB, Fuse, contuctors, fan motor, blower motor, coils, rewinding of motor, fan blade, all plastic components including AHU blower, chiller & AHU, thermostat, selector switches, overload relay, gas leakage arrest, testing, sensors, pressure switch, refilling refrigerant, valves, knobs, copper tubes, strainers, filters, refrigerant accessories, all control, Electrical chord, control panel –PCB, Programming PCB should be repaired or replaced, overhauled at no extra cost immediately when the defects are noticed or informed to the firm.
- 26. The gas and oil shall be charged as and when necessary at no extra cost. There should be including 01Technical Person should be deployed during the programs will conducted at NIFT Auditorium.
- 27. If the firm discontinues the services at any time during the period of contract the Security deposit deposited by the firm shall be forfeited. The charges spent to put the units under running conditions will be recovered from the firm against the Payments due to them.

- 28. The selected firm shall pay a security deposit @ 10% of the value of the contract, which shall be in the form of Demand draft and deposit shall be retained for the entire contract period. The deposit will be refunded on expiry of contract. The deposit will bear no interest during the entire contract period.
- 29. The selected firm shall also sign an agreement in the prescribed format on a non
 judicial stamp paper of value of Rs. 20/- and accepted by the authorized signatory on behalf of NIFT.
- 30. If the firm violates the above conditions or known to violate the above conditions action will be taken to terminate the contract and also to ban the firm taking future contract in NIFT. The security deposit will also be forfeited.
- 31. The complaint should be attended within 24 hours from the time its logged in.
- 32. Repair and corrective work should be executed within 72 hours from the time of attending a complaint, failing which a penalty of Rs.100/- per day / per unit will be charged.
- 33. The firm should ensure 90% uptime for all air conditioners which will be certified by the officials of NIFT, failing which a penalty of Rs.100/- per day / per unit will be levied on the firm.
- 34. Preventive maintenance should be carried out once in a month as per schedule and also service report to be signed by NIFT officials else 20% of the amount will be deducted from the total bill amount for the particular period.
- 35. In case any of the persons deployed by the contractor does not come up to the mark (or) indulges (or) disorderly conduct the contractor shall immediately withdraw such persons on the report of the NIFT in this respect.

- 36. Payment will be made on quarterly basis against the submission of bills along with the copies of the service reports duly signed by the NIFT engineers.
- 37. It shall be the sole responsibility of the contractor to ensure safety of the user and If there is any loss to the institute on account of dishonest and or due to any lapse On the part of the contractor
- 38. NIFT shall not be responsible for death, injury or accident to the contractor / Contractor's employee who may arise out of and in the course of their duties at NIFT Premises
- 39. The contractor should provide all the safety equipment's for their employees
- 40. In case of any accident (or) damage due to negligence (or) unsafe work that Require medical attention, the contractor is wholly responsible
- 41.. The contractor should carry out the shifting of Air conditioner if any as requested by NIFT and cost will be applicable as mentioned in the scheduled of rates.
