NIFT, Chennai intends to dispose of Building and Office items scraps "as is where" condition. The terms and conditions for tender is as follows:-

### **Terms & Conditions**

1. Tender shall be submitted in official tender form only. If submitted in any other form the same shall be summarily rejected. No tenderer shall apply for more than one tender form, This form can be downloaded from NIFT website at free of cost.
2. Tenders received without the prescribed Earnest Money Deposit shall not be considered. MSME and Startups Organization participating in the tender are exempted from depositing EMD. Firms claiming exemption from depositing earnest money must enclose copies of their registration MSEs/MSME details validity as on the date of tender opening along with all its amendments for the subject stores. Offers received without these details or without earnest money will liable to be ignored.
3. The Rate schedule issued with the form of tender listing the disposal of scrap must not be altered by the tenderer. Any modifications/alterations of the schedule considered necessary by the tenderer should be in the separate letter accompanying the tender.
4. The name and address of the tenderer shall be clearly written in the space provided and no overwriting, correction, insertion shall be permitted in any part of the tender unless duly countersigned by the tenderer. The tender should be filled in and submitted in strict accordance with the instructions laid down herein, other wise the tender is liable to be rejected.
5. A Demand Draft of Rs. 5,000/- (Rupees Five Thousand Only) is required to be deposited as Earnest Money Deposit in favor of National Institute of Fashion Technology, Chennai along with the sealed quotation by way of pay order / Demand Draft.
6. The successful tenderer should deposit the value of the material within 3 Working days from the date of award of tender.

7. The successful tenderer should clean / remove the scrap material within 3 working days at his own cost from the date of award of the tender.
8. The tenderer should quote the rate for all varieties of the scrap Materials.
9. The filled in Tender form shall be dropped in a sealed envelope on or before 14.08.2020 at 2pm.
10. Due to COVID 19 lockdown the date, time and mode of opening of tender will be informed over phone or email to the participants (**Kindly mention the contact phone number and email id over the envelop**).
11. The rate should be quoted in Indian Rupees in the rate schedule enclosed along with this terms and condition.
12. The tenderer should signed all the pages of the tender schedule.
13. The award of sale of scrap will be considered based on the highest value quoted for each item.
14. The tenderer should have valid GST registration no.
15. NIFT reserves the right to cancel this tender without assigning any reason thereof.
16. In respect of selection of vendors highest bidder in respect of items of S.No.1 to 10 and S.No. 11 to 13 will be treated separately. In case H1 is different for s.no.1 to 10 and S.No. 11 to 13 items, the successful H1 tender will be awarded accordingly.
17. The tenderer is requested to come and visit NIFT campus from 11.00 am to 2.00 pm on any working day to check the items of disposal before quoting for the scrap.
