The Tenderers shall submit their sealed tenders on or before 10.05.2021 along with the Earnest Money Deposit (EMD) of Rs. 5,000/- in the form of Demand Draft / Pay order in favour of NIFT payable at Chennai.

Terms & Conditions

- 1. Separate sealed quotations are invited for the disposal of each of the said vehicle on the terms and condition mentioned below. Persons/firms, interesting in purchasing the above mentioned vehicle may submit their highest quotations in the enclosed Performa in a sealed cover and the sealed tenders should be super scribed with 'QUOTATION FOR PURCHASE OF CONDEMNED VEHICLE (Ford Fiesta TN07 BK 4444)' and addressed to the Director, NIFT, Chennai along with the EMD of Rs. 5,000/- (Five Thousand only) should be submitted/dropped in tender box kept at Administration department NIFT, Rajiv Gandhi Salai, Taramani, Chennai 600 113.
- 2. The tender documents can be downloaded from NIFT Chennai website at free of cost.
- 3. The vehicle will be available for inspection at NIFT, Rajiv Gandhi Salai, Taramani, Chennai 600 113 between 11 A.M. to 1 P.M. from 19.04.2021 to 07.05.2021
- 4. Quotations received without demand draft towards Earnest Money will not be considered and shall be rejected.
- The successful bidder will be required to deposit the bid amount by means of Demand Draft drawn in favour of NIFT Chennai within three working days of the acceptance of bid.
- 6. The Earnest Money of the successful bidder will be released only after the deposit of the bid amount. Earnest money will not be adjusted as bid amount and will be forfeited if he fails to honour the bid. In case of failure to deposit final bidding amount, the respective vehicle may once again taken up for reauction.
- 7. The delivery of the auctioned vehicle will be arranged only after the successful bidder submits documentary evidence in support of residential status (PAN Card, Aadhar card etc, in case of individual and Registration Certificate etc, in case of firms)
- 8. The auctioned vehicle will be removed by the successful bidder within 7 working days of depositing the bid amount, at their own expenses.
- 9. The vehicle will be disposed off on "as is where is basis" and no guarantee for its worthiness or quality will be given by this Department.

- 10. This Department will not owe any responsibility for transfer of vehicle and for any other liability for using these vehicles for commercial or any other purpose after sale.
- 11. The successful bidder will also be responsible for getting Registration Certificate of the vehicles and/or any other documents as required by the RTO, in his name at his own cost expeditiously. This office will not be responsible for any lapse on his part in this regard.

12. If the successful bidder wants to scrap the vehicle, then he should have to submit the cut part of the chassis number to this office immediately

- 13. The bidder will not be allowed to withdraw their bids and if they do so their earnest money will be forfeited.
- 14. NIFT reserves the right to accept or reject any or all of the quotations without assigning any reason.
- 15. Proforma for offering rate for disposal of condemned vehicle is available at "Annexure"

16. The Upset price for the vehicle No. TN 07 BK 4444 Ford Fiesta (D) 2009 is Rs. 85,000.00 + GST.

- 17. The highest tenderer as the case may be should pay 50% of tendered cost (i.e. which includes EMD Rs. 5,000/- already deposited + Balance amount) on the same day. The remaining 50% shall be paid within 7 (seven) days of acceptance of tender by the competent authority, failing which the EMD amount of Rs. 5,000/- will be forfeited. The remaining bid amount should be deposited in the form of Demand Draft/Pay Order drawn in favor of NIFT, Chennai.
- 18. The delivery/ handling over of the vehicle to the successful tenderer will be made only after full payment and upon submission of proof of valid identification card of the purchaser.
- 19. Tender opening date will be intimated separately over email/phone due to prevailing pandemic situation (participants may specify clearly the contact email id & phone number super scribed over the envelop).
- 20. The tenderers should quote their rates in Annexure 'B' of tender document both in words and figures in the tender schedule, only the highest rate quoted will be considered for evaluation of tenders.
- 21. The entire set of tender documents should be submitted and no portion should be deleted/detached from the tender documents.

- 22. Each tenderer should clearly mention his name and postal addresses with pin code. This office will not be held responsible for the non-receipt of information because of incorrect postal addresses furnished in the tender document.
- 23. The EMD of unsuccessful tenderers will be returned after finalizing the successful tenderer retaining only the EMD of the highest bidder.
- 24. NIFT reserves the right to accept/reject any bidding, to postpone/suspend or to cancel the whole process of the sale at any time without assigning any reason.
- 25. The delivery of the vehicle shall be made after completing sale formalities as required by R.T.O, Chennai.
- 26. The vehicle will be handed over on 'As is where is basis' and no claim for repair/maintenance etc., will be entertained by the NIFT.
- 27. The Road Tax/Insurance/passing of vehicle/transfer charges/road fitness charges etc., shall be borne by the purchaser and NIFT shall not be responsible for the same.
- 28. In case the finalized highest bidder backs out of the tender process/taking of delivery of the vehicle, will be forfeited.
- 29. All Diesel/tow away charges, if needed shall be borne by the purchaser.
- 30. The purchaser shall be bound to remove the vehicle within 10 days after the settlement of payment/other formalities etc.,
- 31. The purchaser shall be responsible for all formalities, responsibilities due to sale/transfer/registration/ownership as required by the concerned authorities. However NIFT will assist wherever required in possible manner under prevailing transport rules.
- 32. Tenders received without the prescribed Earnest Money Deposit shall not be considered. MSME and Startups Organization participating in the tender are exempted from depositing EMD. Firms claiming exemption from depositing earnest money must enclose copies of their registration MSEs/MSME details validity as on the date of tender opening along with all its amendments. Offers received without these details or without earnest money will liable to be ignored.
- 33. The name and address of the tenderer shall be clearly written in the space provided and no overwriting, correction, insertion shall be permitted in any part of the tender unless duly countersigned by the tenderer. The tender should

- be filled in and submitted in strict accordance with the instructions laid down herein, other wise the tender is liable to be rejected.
- 34. Due to COVID 19 lockdown the date, time and mode of opening of tender will be informed over phone or email to the participants (**Kindly mention the contact phone number and email id over the envelop).**
- 35. The rate should be quoted in Indian Rupees in the rate schedule enclosed along with this terms and condition.
- 36. The tenderer should signed all the pages of the tender schedule.
- 37. The award of sale of vehicle will be considered based on the highest value quoted.
- 38. NIFT employees should not participated in this tender process.
