#### परिचय / Introduction

National Institute of Fashion Technology (NIFT) was set up by the Ministry of Textiles, Government of India in 1986 which has been accorded statutory status under the Act of Parliament in 2006 (NIFT Act 2006) for the promotion and development of education and research in the field of Fashion Technology. NIFT provides fashion business education across the country through its network of 17 centers. It provides four years undergraduate (UG) program in design and technology, two years post graduate (PG) program in design, fashion management & fashion technology and a short duration education program to address the specialized needs of professionals and students in the field of fashion. NIFT has its head office at New Delhi with its campuses located at Bengaluru, Bhopal, Bhubaneswar, Chennai, Gandhinagar, Hyderabad, Jodhpur, Kangra, Kannur, Kolkata, Mumbai, New Delhi, Patna, Panchkula, Raibareli, Shillong and Srinagar.

NIFT, Chennai was established in the year 1995 and situated at NIFT, Campus, Rajiv Gandhi Salai, Taramani, Chennai  $-600\,113$ .

NIFT, Chennai intends to Disposal of Electrical and other scrap items <u>"as it where in condition".</u> The terms and conditions for tender are as follows:-

1. The bidder shall deposit an amount of Rs.10,000/- (Rupees Ten Thousand only) as Earnest Money Deposit (EMD) along with the tender form. Tenders received without EMD would be summarily rejected. The EMD of the unsuccessful bidders will be returned to the concerned bidders, within three weeks from the date of opening of the tender. The EMD of the successful bidders shall be returned / refunded after disposal of the scrap items.

- 2. The name and address of the bidder shall be clearly filled in the space provided and no overwriting corrections, insertion shall be accepted in any part of the tender unless duly countersigned by the bidder. The tender shall be filled in and submitted in strict accordance with the instructions laid down herein otherwise the tender is liable to be rejected.
- 3. The filled-in tender is to be submitted in a sealed envelope super scribing "<u>Tender for Disposal of Electrical and other scrap items</u> addressed to the Director, National Institute of Fashion Technology, NIFT Campus, Rajiv Gandhi Salai, Taramani, Chennai 600 113 dropped in the Tender Box in the Institute on or before 14.00 p.m., 24.10.2025. The sealed tenders will be opened on the same day at 16.00 p.m. in the presence of such of the bidders who may wish to be present, either by themselves or by their authorized representatives.
- 4. The bids shall be valid up to two months from the date of opening of the Tender. If bidder withdraws or wishes to modify the terms of the tender during the period, the Earnest Money Deposit shall be forfeited
- 5. National Institute of Fashion Technology, Chennai reserves the right to accept or reject any or all the offers either fully or partly without assigning any reasons.
- 6. Annexure-II consists for Detail of Disposal of Electrical and other scrap Items.
- 7. <u>JURISDICTION FOR LEGAL PROCEEDING Suit</u> or any legal proceedings in regard to this matter arising in any respect under this contract shall be instituted in any court in Chennai only.
- 8. **FORFEITURE OF EARNEST MONEY DEPOSIT** If the Successful Tenderer (referred as "Tenderer") fails to act according to the tender conditions or backs out after the tender has been accepted, the Earnest Money Deposit will be forfeited by NIFT Chennai.
- 9. The successful tenderer should deposit the total amount of the materials within 2 days from the date of award of order.
- 10. The successful tenderer should clean / remove the scrap material within 3 Days at his own cost from the date of award of the order.
- 11. If successful tenderer fails to remove the scrap items within the stipulated time, a penalty @ Rs.500/- per day shall be levied.

- 12. The tenderer should quote the rate for all scrap items. Partial quoting will be strictly rejected.
- 13. The filled in Tender form shall be dropped in a sealed envelope on or before 24.10.2025 at 14.00 p.m.
- 14. The tender forms will be opened at 16.00 p.m. on <u>24.10.2025</u> in the presence of the NIFT officials and Tenderer.
- 15. The rate should be quoted in Indian Rupees in the rate schedule enclosed along with this terms and conditions.
- 16. The tenderer should sign all the pages of the tender schedule.
- 17. The award of sale of scrap will be considered based on the **<u>Highest quoted value [H1]</u>** quoted for each item and total value.
- 18. The tenderer is requested to visit NIFT Main Campus from 10.00 a.m. to 5.00 p.m. on any working day before quoting for the scrap tender.
- 19. EMD will be forfeited, if the successful tenderer after receipt of order fails to remove the items within 3 days.
- 20. Copy of previous work orders should be enclosed for verification.
- 21. MSME certificate for claiming Relaxation for prior experience and turnover criteria as per Department and expenditure vide OM NO. F20/2/2014-PPD (pt.) dated 20.09.2016 and MSME OM F.No.1(2)(1)/2-14-MA Part dated 10.03.2016.
- 22. GST, Income Tax (TDS) as applicable at prevailing rate will be deducted at source.
- 23. NIFT reserves the right to accept or reject any or all the tender without assigning any reason.
- 24. Any document to be found, mismatch/not clear/missing the participants is liable to be disqualified.
- 25. Uploading irrelevant document for evaluation criteria the participants is liable to be disqualified.
