NIFT provides fashion business education across the country through its network of 17 centers. It provides four years undergraduate (UG) program in design and technology, two years post graduate (PG) program in design, fashion management & fashion technology and a short duration education program to address the specialized needs of professionals and students in the field of fashion. NIFT has its head office at New Delhi with its campuses located at Bengaluru, Bhopal, Bhubaneswar, Chennai, Gandhinagar, Hyderabad, Jodhpur, Kangra, Kannur, Kolkata, Mumbai, New Delhi, Patna, Panchkula, Raibareli, Shillong and Srinagar.

- 4. The bids shall be valid up to two months from the date of opening of the Tender. If bidder withdraws or wishes to modify the terms of the tender during the period, the Earnest Money Deposit shall be forfeited
- 5. National Institute of Fashion Technology, Chennai reserves the right to accept or reject any or all the offers either fully or partly without assigning any reasons.

- 10. The successful tenderer should clean / remove the scrap material within 3 Days at his own cost from the date of award of the order.
- 11. If successful tenderer fails to remove the scrap items within the stipulated time, a penalty @ Rs.500/- per day shall be levied.

- 12. The tenderer should quote the rate for all scrap items. Partial quoting will be strictly rejected.
- 13. The filled in Tender form shall be dropped in a sealed envelope on or before 30.10.2025 at 14.00 p.m.
- 14. The tender forms will be opened at 16.00 p.m. on 30.10.2025 in the presence of the NIFT officials and Tenderer.
- 15. The rate should be quoted in Indian Rupees in the rate schedule enclosed along with this terms and conditions.
- 16. The tenderer should sign all the pages of the tender schedule.
- 17. The award of sale of scrap will be considered based on the **<u>Highest quoted value [H1]</u>** quoted for each item and total value.
- 18. The tenderer is requested to visit NIFT Main Campus from 10.00 a.m. to 5.00 p.m. on any working day before quoting for the scrap tender.
- 19. EMD will be forfeited, if the successful tenderer after receipt of order fails to remove the items within 3 days.
