1. Hot air bonding tape laying machine with differential speed top and bottom roller.

2. Bed type should be raised bed or inclined post bed for ease of work with 2D & 3D construction.

3. Should be able to work on straight and curved seam.

4. Should be able to work with woven knit and spandex fabrics.

5. Digital tape tensioner synchronise to roller movement.

6. Electronic heating system for hot air.

7. Should be able to handle maximum Tape width up 22 mm.

8. There should be digital control and display of different operational parameters like tape setting, nozzle setting, fixed tape length, real time variable speed, memory storage option.
