4. Tuition fee for the 2nd semester January-June 2022 (Non – NRI students admitted in NIFT Delhi in 2021-22 Academic Year):

The Non – NRI students admitted in 2021-22 Academic Year are required to pay the tuition fee for January-June, 2022 (2nd semester) as published in the prospectus 2021 i.e. Rs. 1,29,850/- (One Lakh Twenty Nine Thousand Eight Hundred Fifty Only).

The students are required to pay the applicable fee as per the schedule mentioned below and to note the NIFT rules on non-payment and re-registration:

I. Last date of depositing the fee for July-December, 2021 is **15th September, 2021**. Fee with a late fine of Rs.100/- per day can be deposited till **29th September, 2021**.

II. Last date of depositing the fees for the session January to June, 2022 is **8th February, 2022**. Fee with a late fine of Rs. 100/- per day can be deposited till **21st February, 2022**.

III. The name of the student will be struck from the institute rolls without any further notice in case of non-payment of fee after the specified date.

IV. PG students of 3rd Semester will be required to pay the Alumni Association Membership Fee (One time) (Non Refundable) of Rs. 4,800/-.

V. Students rejoining to repeat the semester and those rejoining after availing Leave of Absence (LOA) are requested to contact their concerned CCs before the commencement of the session to complete the formalities. Repeat students will be required to pay the re-registration fee of Rs. 10,000/- + 18% GST = Rs. 1,800/- = **Total Rs. 11,800/-** per absenting semester as well as non-refundable annual charges towards Library and Student Development & Medi-claim fee over and above mentioned amount.
