DEBARMENT NOTICE

Sub: Debarment of M/s Das Restaurant for participation in bidding process at NIFT Delhi campus for a period of three years -reg.

WHEREAS, the contract for providing Canteen Services at NIFT Delhi campus was awarded to M/s Das Restaurant on CPP portal against tender ID No. 2022_NIFT_717428_1, for a period of one year w.e.f. 01/02/2023 to 31/01/2024 vide letter no. 2300(324)/NIFT/DC/Admin/Canteen tender/2022, dated 12/01/2023. The details of the contractor are as under:

Mr. Shiv Dayal Gurjar, M/s Das Restaurant, LB-125, LIG BLOCK, Pratap Apartment, Sector-29, Pratap Nagar, Sanganer Jaipur-302033 Rajasthan.

2. AND WHEREAS, in response to the said order, M/s Das Restaurant vide letter dated 31/01/2023 has denied to provide the canteen services on the rates quoted by him in the tender document.

3. AND WHEREAS, M/s Das Restaurant was again advised vide our letter dated 06/02/2023 and further communication on 13/02/2023 to start the canteen services immediately, however no reply was received.

4. AND WHEREAS, the bid security declaration submitted by M/s Das Restaurant in acceptance of the tender conditions provides that the contractor will be disqualified from bidding for any contract for a period of three years from the date of notification, if he is in a breach of any obligation under the bid conditions.

5. NOW THEREFORE, in view of above, M/s Das Restaurant is debarred for a period of three years from the date of issue of this notice for participation in the tendering process at NIFT Delhi campus, Hauz Khas, New Delhi-110016. This issues with the approval of Competent Authority.
