Terms & Conditions:

1. The quotation must be sent in this format to the Building Department in sealed envelope marked with “**Limited Quotation for providing Comprehensive Annual Maintenance Service Contract of Water Filtration System at NIFT Centre Gandhinagar**” or else liable to be rejected.
2. All the items used for the AMC work should be of ISI/Standard mark and of approved quality as per instruction of NIFT’s Engineer.
3. The rates quoted above shall be inclusive of all charges.
4. These rates should be valid for three months from the date of opening of quotations.
5. The lowest agency shall be evaluated on the basis of total amounts.

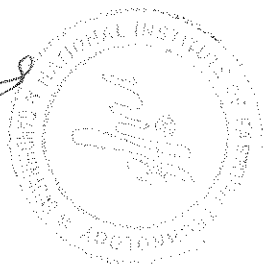
6. The period of contract would be for one year and may be extended thereafter for further 2 years on yearly basis or in terms of required months subject to review & necessity on mutually agreed terms & conditions, if required by the NIFT or any other issue.
7. Last date of receipt of sealed quotations is 6th June 2018 up to 3.00 pm and will be opened on same day at 4.00 pm.
8. **The quotation fee is Rs. 100/- (non-refundable) and EMD is Rs. 2,500/-/- (Rupees Two thousand five hundred only) which is refundable. Both can be deposited by demand draft of National bank in favour of "National Institute of Fashion Technology" payable at Gandhinagar /Ahmedabad. No interest will be paid on Earnest Money Deposit.**
9. Successful agency has to deposit an amount of Rs. 7,500/- (Rs. Seven thousand five hundred) to NIFT as security deposit/performance guarantee. His EMD amount will be converted in SD/PG and balance amount will be deposited by Agency in form of demand draft of National bank in favour of "National Institute of Fashion Technology" payable at Gandhinagar /Ahmedabad.
10. SD/PG will be released after completion of AMC period without interest with no defect liability.
11. Filtration Systems shall be covered by a Comprehensive AMC for one year from the date of receipt of AMC work order. The performance of the filtration systems along with the quality of output water shall be successfully demonstrated and recorded by the agency in presence of NIFT representative prior to acceptance of Systems by NIFT. Any defect noticed during the AMC period shall be attended by agency within 24 hrs. including repair/replacement of affected part of system without any additional charge. In case major repairs, requiring the unit to be taken out by the agency at his workshop, all arrangements including TO and FRO Transportation shall be made by the agency without any additional charges and the work shall be completed within 48 hours without fail.
12. The agency has to attend to complete the complaint within 24 hours after receiving of complaint.
13. During the AMC period, the agency has to visit 3 times in a month for checking and repairing of the Systems with report submitted to NIFT's official which essentially from the part of scope of AMC work. This aspect is included in the scope of AMC work.
14. Agency has to make the extra visit without any charge beyond the 3 visit, if necessary.
15. The defective component/accessory shall be repaired by the agency; if repairing is not possible then Agency has to replace with new component/accessory without any charge.
16. In case of non-performance, in respect of stipulated time period for completion of work or defect liability of during AMC period of System depending upon the case, the penalty amount shall be deduct from the payment and the decision of Director, NIFT shall be final.
17. During AMC period, for specific item, the agency shall be responsible for dealing such cases with company on behalf of NIFT. The agency shall be responsible for settling such issues.
18. The systems shall be able to give output water (flow rate) continuously @ 10000 Liters/hour.
19. The rejected water shall not be more than approximately 5% of raw water for backwash and cleaning etc.
20. The output water from the water filtration system shall be free from dirt, dust, smell, colour and taste.
21. TDS & other applicable taxes shall be deducted from the bill.
22. All call for services will be attended immediately at NIFT - Gandhinagar Campus.
23. The penalty amount per complaint will be as follow:
 - Faults not rectified within 24 hours @ 250/- per day.
 - If OEM or above specification component is not used as maintenance spare, the cost of the equipment will be paid by the agency or if the equipment becomes unserviceable.

- Beyond 10 days if the equipment gets repaired in the open market by the NIFT, the actual cost of the same shall be recovered from the agency. In extreme cases, the action of forfeiture of security money/pending bill/blacklisting of the firm can be resorted at the discretion of the competent authority or NIFT Gandhinagar.
- 24. In the event of any breach of the terms of the contract, the contractor shall have to bear as penalty specified in the present terms. However, upon a material breach of the contract terms which is not remedied by the contractor within 7 days, NIFT shall be entitled to terminate the present contract without any notice and the contractor shall be required to make good any damage incurred by NIFT.
- 25. In case of any dispute the Jurisdiction of Court will be Gandhinagar.
- 26. NIFT reserves the right to reject any quotation or all quotations without assigning any reason thereof.
- 27. The defective items shall be replaced by the agency without any additional charge during AMC period.
- 28. In case of non-performance, in respect of stipulated time period for completion of work or defect liability of one year after completion of installation of System depending upon the case, the SD/PG shall be forfeited and the decision of Director, NIFT shall be final.
- 29. In case of Warranty/Guarantee exceeds one year for specific item the agency shall be responsible for dealing such cases with company on behalf of NIFT. The agency shall be responsible for settling such issues.
- 30. Water filtration system shall contain all the necessary components and accessories as mentioned above.
- 31. Any deviation from the Technical Specification shall be clearly indicated by the agency in his offer. In case on deviation is not indicated it will be presumed that agency is agreeable to all specification and Terms and Conditions of NIFT.
- 32. The payment for Comprehensive Annual Maintenance Contract shall be released on quarterly basis on satisfactory completion of applicable period under NIFT's general provision of payment for such Comprehensive Annual Maintenance Contract.
- **The agency must visit the site for physical assessment of existing filtration system before quoting the competitive rates.**
- **A formal contract agreement on non-Judicial stamp paper of Rs. 100/- for the work will be signed as per terms and conditions with eligible agency to whom the contract will be assigned.**
