**Circular for payment of Mess fees for the semester Jan.-June, 2024**

The Academic Session January-June, 2024 is commencing from 08<sup>th</sup> January, 2024 for the semester II, IV & VI, all students of NIFT, Gandhinagar Campus (except final year's students i.e. Sem.-IV of PG & Sem.-VIII of UG) will pay semester wise Mess Fees to the Institute as per below mentioned details :

Mess Fess for the Academic Session Jan.-June, 2024 considering total 145 days in the Semester (as per Academic Calendar) :

S. No.	Particulars	Fees for Semester (in Rs.)
1.	For Hostellers and other students availing full facility (i.e. all 04 Meals – Breakfast, Lunch, Snack & Dinner)	21,750.00
2.	For the Day Scholars (i.e. all Meals except Dinner)	16,385.00

**NOTES:**

1. Students who want to avail Mess facility shall pay the Mess fee as mentioned above on or before 08.01.2024 and produce the payment receipt of the same to the Canteen Contractor to avail Canteen/Mess facility.
2. Fees shall be paid in full. Fee once deposited shall not be refunded.
3. Students who do not want to avail mess facility will have to submit prior intimation for the same in writing to the canteen contractor on very First day of commencement of semester i.e. 08.01.2024.
4. **No application for exemption from mess fee will be entertained after 09/01/2024. This can be submitted either in physical form or by email to the canteen contractor on their email id jaiswalcanteena@gmail.com with copy to CC of their respective department.**
5. Entry of students who have opted not to avail mess facility will be restricted to ground floor of the canteen area. They will be served food on payment basis on a la carte basis. However, this will not be full lunch / dinner but will include specified items under snacks category.
6. No Students will be allowed to take food outside the canteen premises.
7. If any student who has declared his/her intention not to avail mess facility and is found taking food which is meant for students who have opted mess facility will be imposed a penalty of Rs. 200/- per day.
8. **Fees will be accepted through RTGS/NEFT only. Bank account details of NIFT, Gandhinagar for RTGS/NEFT is as under :**
