As the bank who will be scoring the highest marks will be selected as Banking Partner of NIFT Gandhinagar with reference to marks mentioned by banks in EOI and presentation, all the Banks are requested to be careful while putting the marks against each parameter as NIFT Gandhinagar will be signing MOU with the selected Bank on the same parameters as mentioned in EOI and presentation and marks filled by bank which may not be changed.

In view of this, Banks are herewith requested to sign an undertaking attached along with EOI in respect of confirmation of services as per data mentioned in EOI and presentation. All the Banks are requested not to put any conditional statement in EOI which may not be considered in evaluation of EOI. NIFT reserves the right to reject any or all the EOI without assigning any reason thereof.

Evaluation Criteria:-

Highest securing marks out of 100 marks will be selected as Banking Partner for NIFT Gandhinagar. Only the Banks who will score equal to or more than 70% of total marks of 80 mentioned in Category A+B+C above ie; 56 marks or more will be called for Presentation.
