परिचय / INTRODUCTION

नेशनल इंस्टीट्यूट ऑफ फैशन प्रौद्योगिकी (NIFT) की स्थापना 1986 में कपड़ा मंत्रालय, भारत सरकार द्वारा की गई थी, जिसे शिक्षा और अनुसंधान के प्रचार और विकास के लिए 2006 में संसद के अधिनियम (NIFT अधिनियम 2006) के तहत वैधानिक दर्जा दिया गया है। निफ्ट अपने 18 केंद्रों के नेटवर्क के माध्यम से देश भर में फैशन व्यवसाय शिक्षा प्रदान करता है | यह फैशन के क्षेत्र में पेशेवर और छात्रों की विशेष जरूरतों को पूरा करने के लिए डिजाइन और प्रौद्योगिकी में चार साल का स्नातक (यूजी) कार्यक्रम, डिजाइन, फैशन प्रबंधन और फैशन प्रौद्योगिकी में दो साल का स्नातकोत्तर (पीजी) कार्यक्रम और छोटी अवधि का शिक्षा कार्यक्रम प्रदान करता है। निफ्ट का प्रधान कार्यालय नई दिल्ली में है और इसके परिसर बेंगलुरु, भोपाल, भुवनेश्वर, चेन्नई, गांधीनगर, हैदराबाद, जोधपुर, कांगड़ा, कन्नूर, कोलकाता, मुंबई, नई दिल्ली, पटना, रायबरेली, शिलांग, श्रीनगर और दमन में स्थित हैं। निफ्ट गांधीनगर परिसर जीएच-0 रोड, गांधीनगर पर स्थित है।

पंजीकरण / Registration

ए) बोलीदाताओं को "नामांकन के लिए यहां क्लिक करें" लिंक पर क्लिक करके केंद्रीय सार्वजनिक खरीद पोर्टल (यूआरएल: http://eprocure.gov.in/eprocure/app) के ई-प्रोक्योरमेंट मॉड्यूल पर नामांकन करना आवश्यक है। सीपीपी पोर्टल पर नामांकन निःशुल्क है।

Bidder then logs in to the site through the secured log-in by entering their user ID / password and the password of the DSC / e-Token.

निविदा दस्तावेज़ों की खोज / Searching for Tender Documents

क) बोलीदाताओं को कई मापदंडों के आधार पर सक्रिय निविदाओं को खोजने की सुविधा प्रदान करने के लिए सीपीपी पोर्टल में विभिन्न खोज विकल्प बनाए गए हैं। इन मापदंडों में निविदा आईडी, संगठन का नाम, स्थान, तिथि, मूल्य आदि शामिल हो सकते हैं। निविदाओं के लिए उन्नत खोज का एक विकल्प भी है, जिसमें बोली लगाने वाले सीपीपी पोर्टल पर प्रकाशित निविदा की खोज करने के लिए कई खोज मापदंडों जैसे संगठन का नाम, अनुबंध का रूप, स्थान, तिथि, अन्य कीवर्ड आदि को जोड़ सकते हैं।

There are various search options built in the CPP Portal, to facilitate bidders to search active tenders by several parameters. These parameters could include Tender ID, organization name, location, date, value, etc. There is also an option of advanced search for tenders, wherein the bidders may combine a number of search parameters such as organization name, form of contract, location, date, other keywords etc. to search for a tender published on the CPP Portal.

निविदा की तैयारी / Preparation of Bids

Bidder should take into account any corrigendum published on the tender document before submitting their bids.

बोलियाँ प्रस्तुत करना / Submission of Bids

No extra charge made in consequence of any misunderstanding or incorrect information on any of these points or on the grounds of insufficient description will be allowed.

The Tenderer shall be deemed to have satisfied himself before tendering as to the correctness and sufficiency of his tender for the works and of the rates and prices quoted in the schedule of quantities which rates and prices shall except as otherwise provided cover all his obligations under the contract and all matters and things necessary for the proper completion and maintenance of the works.

Further, L1 (lowest bidder) will be decided on the basis of quoted amount given by the bidder. However, least quoted amount will be the sum of price bids (grand total) quoted by the bidder.

Before filling the tender the, Tenderer should check all drawing and schedule of quantities and will get an immediate clarification from Engineer in Charge as required on items not clearly understood. Any claim for any loss or compensation will not be entertained on this account.

The rates quoted by the tenderer shall be for finished work measured at site and should include supply of all materials, wastage, labour, tools tackles, marking out and clearing of the site and liaison charges and which is not specifically mentioned here. The total amount/rate shall also be inclusive of GST, works contract tax and any other duties / taxes / cess levied by the Government or any other Concerned Authorities.

Contract can be terminated by either party by giving three months' notice in advance. The contractor shall undertake that any act of omission or commission including theft, by his staff shall be his sole responsibility and further that he would compensate it along with any loss/damage occurring on account of his staff individually or collectively in the institute immediately.

The contractor shall ensure that the staff engaged by him for Interior work shall not smoke beedies, cigarettes or take alcoholic drinks and nor they are allowed to chew pan, areca nut, tobacco items etc. in the campus.

The Bidders shall also give particulars of the banker(s), for reference to NIFT.

VALIDITY OF THE OFFER

The offer should be valid for six months from the date of receiving of bids; it can be further extended for the period of three months.

RIGHT OF ACCEPTANCE

After qualifying technical criteria, lowest bidder will be considered for award of work order. NIFT reserves the right to accept a part of the quantity offered, and the Bidders shall supply the same quote rates The Bidders shall supply the ordered quantity at quoted unit rates. NIFT reserves the right to reject any or all offers received in response to tender or cancel/withdraw the tender notice without assigning any reason Bidders. NIFT may call upon one or more Bidders for demonstration of all or any quoted item at NIFT Campus. No cost will be paid for such demonstrations.

DELIVERY PERIOD

Delivery of all deliverables at NIFT shall have to be completed within 6 weeks from the date of placing a firm order by NIFT. The successful installations, commissioning and acceptance testing shall have to be completed within 60 to 90 days from dated of order issued. Bidders are requested to specifically note that time is the essence of this tender and therefore no request for extension of delivery period by the Bidders, except due to reasons of force majeure shall be entertained.

The indenter's right to inspect, test and, where necessary, reject the Goods after the Goods arrival at Customer Site shall in no way be limited or waived by reason of the Goods having previously been inspected, tested and passed by the Purchaser or its representative prior to the Goods shipment.

The prices mentioned in BOQ shall be considered for evaluation and comparison of bids. PENALTY CLAUSE

The warranty shall cover all products and services provide by the Bidder. No boarding, lodging or transport shall be provided by NIFT on this account.

PAYMENT TERMS

25% of the payment against delivery of all materials to site and physical inspection by the NIFT in Charge.

75% on successful installation and acceptance of all items along with documentation / reports and satisfactory operation.

Payment as per physical progress after approval of Competent authority.

TERMINATION FOR DEFAULT

The Purchaser may, without prejudice to any other remedy for breach of contract, by written notice of default sent to the Bidder, terminate the Contract in whole or part:

If the bidder fails to deliver any or all of the Goods within 45 working days from the date of purchase order, or within any extension thereof granted by the Purchaser or

If the Bidder fails to perform any other obligation(s) under the Contract/Purchase order.

If the Bidder, in the judgment of the Purchaser has engaged in corrupt or fraudulent practices in competing for or in executing the Contract.

For the purpose of this clause:

"Corrupt practice" means the offering, giving, receiving or soliciting of anything of value of influence the action of a public official in the procurement process or in contract execution."

"fraudulent practice: a misrepresentation of facts in order to influence a procurement process or the execution of a contract to the detriment of the purchaser, and includes collusive practice among Bidders (prior to or after bid submission) designed to establish bid prices at artificial non- competitive levels and to deprive the purchaser of the benefits of free and open competition;"

In the event the Purchaser terminates the Contract in whole or in part, pursuant to Clause above, the Purchaser may procure, upon such terms and in such manner, as it deems appropriate, Goods or Services similar to those undelivered, and the Bidder shall be liable to the Purchaser for any excess costs for such similar Goods or Services. 
