NIFT has its Head Office at New Hyderabad with its Campuses located at Bengaluru, Bhopal, Bhubaneswar, Chennai, Daman, Gandhinagar, Hyderabad, Jodhpur, Kangra, Kannur, Kolkata, Mumbai, New Hyderabad, Panchkula, Patna, Raebareli, Shillong, Srinagar and Varanasi.

**Tenure of Contract:** The Hiring of vehicle contract for a period of maximum **(03 Years) Three Years** from the date of award of the contract. NIFT shall be at full liberty to call for fresh tender at the expiry of the present agreement. The Decision of the NIFT is final in this regard.

**Eligibility Criteria :-**

- a. Bidders should have valid license with **minimum 03 years of experience** & professionally competent service in any Educational Institute or Repute/Government/Semi. Govt./Public Sector Undertaking/ Autonomous Body/Reputed Corporate is eligible to apply.

6. The Vehicles shall be required for transportation of faculty, officials, staff and students are generally within Hyderabad and within the state of Telangana/ Andhra Pradesh as and when required.
7. The vehicle to be provided shall be of 'Commercial' type and should have all the valid relevant papers/ documents [viz. Registration, Road Tax, Insurance, etc.] and preferably not more than three years old.
8. The quoted price shall be inclusive of all, i.e. fuel, maintenance, driver's charges, etc. However, Parking/ Toll charges will be paid extra by NIFT on submission of original token/slips/receipts duly signed by the user of the vehicle/concerned NIFT official.

9. The Institute will count/take into consider milometer/kms from Garage-in, Garage-out charges shall be considered for 10 KMs (5 KM In + 5 KM Out) reporting at NIFT Hyderabad Campus, Hi-Tech city, Madhapur.
10. The service provider shall get entries of the Milo-meter of vehicles at the security gate, in the prescribed register, each time it leaves the Institute for duty and at the time of arrivals from the outside. He has also to get the car duty book/Slip signed from the Guest.
11. The Driver/s must have valid driving license(s) and active mobile phones (to be provided by the agency) while on duty.
12. The quoted price will be valid for entire period of contract from the date of acceptance of work order. No payment will be made in advance. The payment shall be released on completion of service, satisfactory service and based on the certification of service by the concerned NIFT Officials/Departments.
13. Applicable Taxes will be deducted during payment.
14. The log book/duty slip/call report for use of the vehicle shall be maintained by you, duly signed by the concerned NIFT official and shall be submitted along with the bills.
15. Copies of valid PAN, GST Registration, NSIC, MSME, Startup Registration number of Agency and experience certificate should be submitted with your bid.
16. The contract will be awarded on the basis of lowest rate (L-1) quote by the agency for AC and Non-AC vehicles.
17. Individual signing the bid or other documents connected with the bid must specify whether he signs as:
  - A) A sole proprietor of the concern or constituted attorney of such sole proprietor.
  - B) A partner of the firm if it is a partnership firm, in that case he must have authority to execute contracts on behalf of the firm and refer to arbitration disputes conceiving the business of the partnership either by virtue of partnership agreement or by a power of attorney duly executed by the partners of the firms.

18. In case of any breakdown of vehicle on duty, the service provider shall make arrangement CPP Portal for providing another vehicle. In such a case, mileage from garage to the point of breakdown would not be paid.
19. Payment and receipts to Government and Semi Government Agencies would be rounded off to the nearer higher rupee and in other cases the rounding off will be to nearest, i.e. paise 50 or above will be rounded off the near higher rupee and paise less than 50 will be ignored.
20. The bidder shall abide by the Rules and Regulations of the NIFT, as may be enforced from time to time. The Contractor will have to work in close co-operation with others administration department.
21. NIFT shall not be responsible for any challan, loss, damage or any accident of the vehicle or to any other vehicles or for the injury to the driver or to any other third party.
22. The loss or damage or legal expenses on this account shall be borne by the Service Provider.
23. **The Service Provider should have local Registered/Branch Office in Hyderabad.**
24. NIFT Hyderabad can ask the service provider to supply the vehicles as when required in working days, Saturdays, Sundays and holidays also.
25. All disputes are subject to Hyderabad Jurisdiction only.
26. NIFT reserves the right to accept or reject the bid in part or full at its sole discretion without assigning any reason whatsoever
27. The contractor will be fully responsible for the drivers, petrol-diesel, maintenance, RTO formalities, Insurance etc. The vehicles must be in the name of the contractor or its firm and have RTO permit for all over Telangana /Andhra Pradesh.
28. The vehicles should be insured fully including third party insurance.
29. The drivers engaged by the contractor shall not smoke, chew tobacco products, gutkas or consume liquor / alcoholic drinks.
30. The driver engaged by the contractor should always carry a mobile phone, which has to be provided by the contractor.
31. The drivers engaged by the contractor must be well informed about the routes, roads and important localities / landmarks of the Hyderabad city.
32. Monthly payment will be done against submission of bills along with signed/certified on the production of Duty Slips.
33. The Agency should follow to all norms fixed by the Telangana/ AP Road Transport Authority for running the vehicles.
34. Contractor/Agency should not be black listed by any organization
35. Even after qualifying in technical bid, the financial bid may not be accepted if found not in order.
36. The Contractor must keep the Vehicle clean, neat and create a good ambiance in consultation with the NIFT officials.
37. All statutory obligations under various laws, imposed from time to time will be to be met by the Contractor for which no extra payment shall be made to him. NIFT will no way be responsible for any default with regard to statutory obligations if any.

**Termination of Contract:**

- a. In case of unsatisfactory performance or failure to comply with the terms and conditions of the contract, the contract shall be liable to be terminated by the department by serving **Two months prior notice**.
- b.
