NIFT, Hyderabad intends to disposal of scrap items "As is where is" condition. The terms and conditions for agency are as follows:-

General Terms & Conditions

- 1. The Agency shall be submitted in official form only. If submitted in any other form the same shall be summarily rejected. No agency shall be issued more than one form.
- 2. The Agency submitted quotation without the prescribed Security Deposit (SD) shall not be considered.
- 3. The Rate schedule issued with the form of agency listing the disposal of scrap items must not be altered by the agency.
- 4. The name and address of the agency shall be clearly written in the space provided and no overwriting, correction, insertion shall be permitted in any part of the quotation unless duly countersigned by the agency.
- 5. The Agency should be filled in and submitted in strict accordance with the instructions laid down herein; otherwise the quotation is liable to be rejected.
- 6. A Demand Draft of Rs.13, 000/- (Rupees Thirteen Thousand only) is required to be deposited as Security Deposit in favor of National Institute of Fashion Technology, Hyderabad along with the sealed quotation by way of pay order / Demand Draft.
- 7. The successful agency should deposit the value of the material immediately through RTGS/NEFT/DD in favor of NIFT Payable at Hyderabad on allotment order.
- 8. The successful agency should clean / remove the scrap material within 2 Days after deposit the total value at own cost from the date of award of the order.
- 9. If successful agency fails to remove the items within the stipulated time, a penalty @ Rs.1000/- per day shall be levied.
- 10. The agency should quote the rate for all varieties of the scrap materials. Partial quoting will be strictly rejected.
- 11. The filled in sealed quotation form shall be dropped in a sealed envelope on or before 22.11.2024 at 3.00 p.m.
- 12. The sealed quotations will be opened at 3.30 p.m. on 22.11.2024 in the presence of the NIFT officials.
- 13. The rate should be quoted in Indian Rupees in the rate schedule enclosed along with this terms and condition.
- 14. The agency should sign all the two pages i.e, terms and conditions and quotation.
- 15. The award of sale of scrap will be considered based on the highest value quoted for each item.
- 16. The agency should have valid PAN number/GST Number .(Copy Attached)
- 17. The agency should have submitted Aadhar Number (Certified copy attached)
- 18. The agency is requested to come and visit NIFT campus from 10.00 a.m. to 5.00 p.m. on any working day to check the disposal items before quoting for the scrap.
- 19. EMD will be forfeited, if the successful agency after receipt of order fails to remove the scarp items within period of 5 days from the date of order.
- 19. GST @ 18% applicable on total amount.
