#### 11. **Buyer Added Bid Specific ATC**

Buyer Added text based ATC clauses

1. It is generally observed that prospective bidders submit/ upload desired documents in duplicate or triplicate or submit un-wanted/irrelevant documents with the bid which lead to confusion and there might be chances to skip desired document while evaluation. Therefore, it is instructed to upload only desired/ relevant documents as per the requirement mentioned in the bid.
2. If the L1 quoted vendor are found more, the decision of NIFT authority is final and preference shall be given to local service providers or to choose by running GeM options.
3. Preference will be given to vendors with experience in any NIFT Centres / with reputed institutes like IIT/NIT/NID or any other National Importance Educational Institution and service providers with State/Central Government/Statutory bodies/Autonomous bodies etc.
4. Interpretation of Clauses: In case of ambiguity in the interpretation of any of the clauses in the bid document, the Director Hyderabad interpretation of the clauses shall be final and binding on the supplier.
5. Jurisdiction: In case of any dispute the Jurisdiction of Court will be Hyderabad, Telangana. In case of disputes raised by the Service Provider, a representation will be made only by the supplier or the authorized representative of the supplier and the decision of the Director Hyderabad will be binding on the supplier.

#### 14. **Turnover**

OEM Turn Over Criteria: The minimum average annual financial turnover of the OEM of the offered product

during the last three years, ending on 31st March of the previous financial year, should be as indicated in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the OEM is less than 3 year old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria. In case of bunch bids, the OEM of CATEGORY RELATED TO primary product having highest bid value should meet this criterion.

#### 15. **Service & Support**

Dedicated /toll Free Telephone No. for Service Support : BIDDER/OEM must have Dedicated/toll Free Telephone No. for Service Support.

#### 16. **Service & Support**

Escalation Matrix For Service Support : Bidder/OEM must provide Escalation Matrix of Telephone Numbers for Service Support.

#### 17. **Warranty**

Warranty period of the supplied products shall be 1 years from the date of final acceptance of goods or after completion of installation, commissioning & testing of goods (if included in the scope of supply), at consignee location. OEM Warranty certificates must be submitted by Successful Bidder at the time of delivery of Goods. The seller should guarantee the rectification of goods in case of any break down during the guarantee period. Seller should have well established Installation, Commissioning, Training, Troubleshooting and Maintenance Service group in INDIA for attending the after sales service. Details of Service Centres near consignee destinations are to be uploaded along with the bid.
