## आदेश / ORDER

WHEREAS an Act, {The Sexual Harassment of Women at Workplace (Prevention, Prohibition and Redressal) Act, 2013 (No. 14 of 2013)} to provide protection against sexual harassment of women at workplace and for prevention and redressal of complaints of sexual harassment and matters connected therewith thereto has been enacted by Parliament of India.

WHEREAS, as per the Chapter II of the said Act, every employer of a workplace shall, by an order in writing has to constitute a committee to be known as the "Internal Complaints Committee".

AND WHEREAS the Internal Complaint Committee shall inter-alia consist of a Chairperson and not less than two members from amongst employees and one member from non-governmental organization, provided that at least one-half of the total members so nominated shall be women.

NOW, THEREFORE, I Prof. G.H.S. Prasad, Phd, Director, NIFT Campus, Jodhpur in compliance of the provisions given in Section-4 of said Act, order formation of an Internal Complaints Committee having the following members:-
