EOI Terms and Conditions

- 1. A copy of registration Certificate of the Firm/Company/Vendors is necessary.
- 2. A copy of PAN Number of the Firm/Company is mandatory.
- 3. A copy of GST Number of the Firm/ Company is also required.
- 4. Each Vendor has to certify that all the terms and conditions EOI met as above.
- 5. The successful tenderer will have to submit a sum equivalent to 10% of contract value less EMD as security deposit immediately on acceptance of Work Order in the form of demand draft of nationalized bank/schedule bank only in favor of NIFT, Jodhpur payable at Jodhpur. No interest shall be paid on such security deposit, which shall remain with Institute during the continuance of the contract and it shall be released only three months after the expiry or termination of the contract, subject to clearance of all dues by the contractor.

Note:

1. The bidder may visit, examine the work and satisfy themselves before submitting their offer on any working day with permission of the Authority.

- 2. The CAMC will include repairs/replacement of electro mechanical part of STP plant system
- **3.** The mentioned work is indicative only. Any equipment/device/wiring/panel etc. which is not indicated in the list, but forms part of the CAMC, shall be deemed to be included in the scope of work.
- **4.** The contractor shall carry out visit for the periodic preventive maintenance (once in three months) in a year.
- 5. The firm should not have been black-listed by any Government organization/PSU etc.
- **6.** The AMC will be awarded to firm for one year which may be extendable further, up to two more year on the basis of satisfactory performance of the firm in the first year. AMC will be terminated any time, if the service is found unsatisfactory.

Scope of Work:

The scope of work involves the maintenance of Sewerage Treatment Plant and shall cover the following:

- 1. Diagnose the faults, repair/replace the faulty parts etc. and rectify the defect of STP plant.
- 2. The rates of comprehensive O & M of STP shall include repair/replacement of pumps, screens/ filters, air-blowers, diffusers repair/replacement of all minor and major parts including electric inventories. All tanks should also be cleaned regularly.
- 3. No carriage charges would be payable by NIFT for removal of sludge from plant to the area defined as dumping station by Jodhpur Municipal Corporation, out-side the campus.
- 4. The contractor shall be responsible for operation & maintenance of all units of STP and ensure uninterrupted working condition.
- 5. The service Engineer will perform/carry out Routine Operation, inspection, checking and servicing of all parts in every 3 months. The service report shall be submitted to building department.
- 6. The rates of comprehensive O & M of STP shall include repair/replacement of pumps, screens/ filters, air-blowers, diffusers repair/replacement of all minor and major parts including electric inventories. All tanks should also be cleaned regularly.
- 7. The contractor shall be responsible for operation & maintenance of all units of STP and ensure working condition.
- 8. Ensure uninterrupted working condition of STP plant.
- 9. The contractor will be responsible for any unscheduled maintenance call, either in writing or over phone from engineer in charge for corrective and remedial maintenance service to set right the malfunctioning of equipments.
- 10. The party have to attend the call within 24 hours of the complain and make free of cost additional visits during the contract period, as and when required, in the event of any breakdown, malfunctioning, In case of delay by more than 24 hours in attending to maintenance call given, penalty will be charged of Rs 500 per day.

- 11. All tools, tackles, instruments, all spare items and consumable etc. required during AMC period under scope of contractor.
- 12. No spares, consumable or any other items will be supplied by NIFT.
- 13. For repair requiring the removal of any parts thereof to contractor's service centre or any factory cost will be borne by the contractor.
- 14. The contractor take precautions for the safety of his employee in performance of the contract and NIFT, Jodhpur will not take any responsibility or liability in case of accident/ death of licensee's employees.
- 15. If the work of the contractor is found to be unsatisfactory, the job will be entrusted to any other firm/Party at risk and cost of the contractor.
- 16. NIFT reserves the right to terminate the contract at any time without assigning any reason. In this condition, the decision of NIFT shall be final and binding on the contractor.
- 17. Outgoing material from NIFT Jodhpur against proper Gate Pass duly signed by the authorized signatory is required.
- 18. Conditional bid will be treated as unresponsive and are liable to be rejected.
- 19. The payment shall be made quarterly on satisfactory completion of the job and T.D.S and other Govt. taxes as applicable will be deducted.
- 20. The rates of CAMC shall be inclusive of all taxes, duties octroi, works contract tax, cartage loading, unloading and any other statutory taxes, GST complete in all respects, valid for a period of one year from the date of award of contract.
- 21. L-1 will be decided on the basis of Grand total. No other charges will be paid except the Grand total amount quoted.
- 22. The vendor/representative of company may visit the site(NIFT Jodhpur) and understand the scope of work completely before participating in the rate enquiry process sa me and seek clarifications if so desired.
