### NOTIFICATION

As per the mandate of the Act, {**The Sexual Harassment of women at Workplace (Prevention prohibition and Redressal) Act, 2013 (No. 14 of 2013)**}; to provide protection against sexual harassment of Women at Workplace and for Prevention and Redressal of complaints of sexual harassment and matters connected there with or incidental thereto has been enacted by the Parliament of India.

WHEREAS as per the chapter II of the said Act, every employer of a workplace shall, by an order in writing has to constitute a committee to be known as the "Internal Complaints Committee"

AND WHEREAS the Internal Complaint Committee shall inter-alia consist of a Presiding Officer and not less than two members form amongst employees and one member from non Government organization provided that at least one-half of the total members so nominated shall be women.

NOW, THEREFORE, I **Prof. (Dr.) Rahul Chandra, Director, NIFT Campus Kangra** in compliance of the provisions given in Section – 4 of said Act, order re-constitution of an Internal Complaints Committee having the following members:
