Terms and Conditions:

- 1. The quoted rate should be inclusive of all applicable taxes, duties, transportation, loading, unloading, installation charges, and any other incidental costs.
- 2. The quotation must be submitted strictly as per **Annexure-I**. Evaluation will be based on the grand total of all service items.
- 3. The supplier / service provider must attach valid copies of PAN Card and GST Registration Certificate along with the quotation.
- 4. The supplier / service provider is required to visit the site and understand the exact scope and requirements prior to submission of the quotation.
- 5. The event 'Converge 2025' is scheduled from 07.10.2025 to 09.10.2025 at NIFT Kannur Campus and Kannur University, Mangattuparamba, Dharmashala, Kannur.
- 6. NIFT Kannur will provide its GST Number. The supplier is required to raise a GST Invoice accordingly.
