1. INTRODUCTION:


National Institute of Fashion Technology (NIFT) was set up by the Ministry of Textiles, Government of India in 1986 which has been accorded statutory status under the Act of Parliament in 2006 (NIFT Act 2006) for the promotion and development of education and research in field of Fashion Technology. NIFT provides fashion business education across the country through its network of 16 centers. NIFT has its head office at New Delhi with its campuses located at Bengaluru, Bhopal, Bhubaneswar, Chennai, Gandhinagar, Hyderabad, Jodhpur, Kangra, Kannur, Kolkata, Mumbai, New Delhi, Panchkula, Patna, Raibareli, Shillong and Srinagar.

2. INVITING EXPRESSION OF INTEREST (EOI):

NIFT Kolkata invites Expression of Interest (EOI) for Accommodation Premises which will be used as Guest House for stay of it's officials/ persons related to NIFT matters. The said Accommodation Premises may be semi-furnished and shall consist of 02/ 03 BHK, one dining/ hall and two (2) bathrooms/ toilets out of which at least one should be attached with one of the bedrooms. The premises should be preferably within the proximity/ same vicinity or preferably within 5 Km to 15 Km from the NIFT Campus (Salt Lake City, Metropoliton area, near E.M.By Pass, New Town/ Rajarhat, Ruby/ Kasba, etc.). Other preferences includes modular kitchen, electrical fittings including Fans, AC, Lights, cupboards, Almirahs in the rooms, hall, etc. Apart from rentals, monthly electricity charges will be borne by NIFT Kolkata. In this regard NIFT would like to go for lease agreement preferably **from 01.12.2021**.

3. ELIGIBILITY CRITERIA:

- I) The owner should have absolute & exclusive ownership of the premises and should have clear, marketable title and undisputed possession.
- **II) Total Plinth area required:** at least 800 sq.ft. -1200 sq.ft. of 02 BHK/ 03 BHK one dining/ hall and two (2) bathrooms/ toilets out of which at least one should be attached with one of the bedrooms.
- III) Preferred Locations: preferably within the proximity/ same vicinity of NIFT Campus, Kolkata or preferably within 5 Km to 15 Km from the NIFT Campus, Kolkata (Salt Lake City, Metropoliton area, near E.M.By Pass, New Town/ Rajarhat, Ruby/ Kasba, etc.). from NIFT Kolkata Campus.







- **IV) Period of Lease/Rental:** For 11 months only with provision of extension/ renewal as may be required by NIFT
- 4. **Submission of EOI:** The EOI has to be submitted as per the following details under Technical and Financial system:
- a. The EOI consists of Technical EOI (Annexure-A) and Financial EOI (Annexure-B) and are to be submitted in separate sealed envelopes superscribed with 'EOI for Hiring of Guest House Accommodation -Technical' and 'EOI for Hiring of Guest House Accommodation – Financial'.
- b. Both the above sealed envelopes of Technical EOI (Annexure-A) & Financial EOI (Annexure-B) will have to be placed together in a third envelope superscribed with 'EOI for Hiring of Guest House Accommodation' and may be sent or dropped in the Drop Box placed in the Purchase section at the following address:

NIFT Campus, BLOCK-LA, PLOT-3B, SECTOR-III, SALT LAKE CITY, KOLKATA-700106 so as to reach the office of Joint Director on or before the due date mentioned above.

The name & address of the Owner/ Party should be mentioned on the cover of this envelope.

General Requirements:

i) The lease will be for a period of 11 months only which may be extended/ renew for further periods based on requirement of NIFT on mutually agreed terms and conditions.

ii) The interested owner / party may please note that **No Advance** payment of rent would be remitted by NIFT.

iii) The owner / party shall pay all the Maintenance charges (Electrical / Fittings & Fixtures) municipal taxes / water charges / taxes /maintenance charges and other levies for the premises regularly for the lease period and submit copies of the same to NIFT for records. NIFT shall pay only the electricity consumption charges for the premises.

iv) The offer should be valid for three months from the date of offer and should reach not later than the due date & time mentioned above. NIFT further reserves the right to reject all offers without assigning any reasons.

v) Guest House owner will ensure uninterrupted Power Backup i.e. UPS / Inverter etc. The maintenance of Invertor, Batteries would be borne by the Guest House owner only.

vi) The Guest House owner will pay and discharge all the statutory charges, taxes, ground rent or penalties of any nature including municipal taxes, water taxes whatsoever levied by any local authorities, municipal authority or any Statutory Development Authority or a Government





Department or agency in relation to said premises. NIFT will be liable to pay only monthly rent along with electricity charges as per the actual consumptions only.

6. INSTRUCTIONS TO OWNERS / PARTIES:

1. The owner / party shall arrange for all statutory clearances such as Municipal, Urban land Ceiling, Nil Encumbrance etc.

2. Premises should have all basic amenities like attached washroom in both the rooms, modular kitchen, equipped with electrical fittings including ac/ fans, tube-lights and Almirahs in both rooms, hall etc., parking space for vehicles, proper approach from main road etc. Lift in case required, depending on the floor level. The premises should be ready in all respects for occupation.

3. In case the premises are owned by more than one owner, such joint owners can quote through one of them holding Power of Attorney for others.

- 5. Broker / Property dealer need not apply. **NIFT does not NEGOTIATE THROUGH BROKERS AND NO BROKERAGE SHALL BE PAID whatsoever.**
- 6. The successful owner/ party will execute lease agreement with NIFT as per our standard format.
- 7. The offered premises shall be evaluated on the basis of the facility offered/quoted. A team of NIFT official may visit the offered premises for evaluation. Financial EOI of only techno commercially recommended/acceptable parties shall be opened for further consideration. No reason(s) and/or explanation, whatsoever, shall be given to unqualified owner / party. NIFT reserves the right to reject any or all the offers or may cancel the EOI without assigning any reason and the decision of NIFT to this effect shall be final and binding on all the owners/ parties participated in the EOI. The lowest offer may not be the only criteria for selection of successful owner/ party; factors, viz. location, plinth area, additional facilities, etc. will also be considered for selection of the successful owner/ party.
- 8. NIFT will pay the monthly rent by 10th of next month of every completed month. Monthly electricity charges (based on the actual consumption as per the dedicated meter readings) shall be paid by the owner/ party to the Electricity Board within the due date which will be reimbursed by NIFT on submission of the receipt of the same.
- 9. There shall not be any legal case pending /contemplated in any court of law against the ownership of said property.
- 10. If the property is transferred before the end of the lease period, the rights of the lease shall not be afected in any manner whatsoever.
- 11. The deed agreement may be cancelled / terminated by either party by giving 01 month notice period.
- 12. Conditional offers will not be accepted.
- 13. Any query/clarification with respect to the EOI may get cleared prior to submission; concerned NIFT official(s) may be contacted (033-23357546) in this regard in between 10:00 am to 04:00 pm on any working





day. However, no query will be entertained/ clarified beyond the due date of submission of the EOI.
