3.2 Economically Weaker Section (EWS):

Candidates seeking benefit of reservation and relaxation shall submit caste certificate in prescribed format issued by Competent Authority. In case of EWS category candidate seeking benefit must submit income proof issued by appropriate authority. The benefit of reservation under EWS can be availed upon production of an Income and Asset Certificate issued by a Competent Authority. The Income and Asset Certificate issued by any one of the following authorities in the prescribed format shall only be accepted as proof of candidate's claims belonging to EWS:-

(i) District Magistrate/ Additional District Magistrate/ Collector/ Deputy Commissioner/ Additional Deputy Commissioner/ 1st Class Stipendiary Magistrate/ Sub-Divisional Magistrate/ Taluka Magistrate / Executive Magistrate, Extra Assistant Commissioner.

(ii) Chief Presidency Magistrate/ Additional Chief Presidency Magistrate/ Presidency Magistrate

(iii) Revenue Officer not below the rank of Tehsildar and

(iv) Sub-Divisional Officer or the area where the candidate and /or his family normally resides

Fee can be paid through online mode using NEFT, Net Banking, Credit Card, Debit Card, UPI accessing the NIFT portal <https://www.nift.ac.in/kolkata> (click on 'Fees Payment' under QUICK LINKS available at the bottom of the web page) or through Demand Draft with the following conditions:

(i) Demand Draft for the requisite fee should be drawn in favour of "NIFT Kolkata" payable at Kolkata. Applicant must write his/her name, address and post applied for on the back of the Demand Draft. The DD should be drawn post publication of the recruitment notice.

(ii) The Receipt of fees paid online or the original Demand Draft must be enclosed with the application form.

(iii) Applications received without the prescribed fee shall not be considered and summarily rejected. No correspondence/ representation against such rejection will be entertained.

(iv) The fee once paid shall not be refunded or re-adjusted under any circumstances.

(v) The candidates applying for more than one post, shall be required to apply separately along with the required application fees for each post. However, applicant should choose the post for which he likes to appear for the exam in case he becomes eligible and selected for more than one post.

5. CONCESSION & RELAXATION

a) Age relaxation to SC/ST/OBC: The upper age limit is relaxable upto 05 years for SC/ST and 03 years for OBC subject to production of Caste Certificate issued by the Competent Authority. For availing the benefit of Other Backward Classes, the candidates are required to produce the latest and valid OBC non-creamy layer certificate on the prescribed proforma applicable for appointment to the post of Central Govt.

b) Age relaxation to Persons With Disability (PWD): Age relaxation of 10 years is allowed (total 15 years for SCs/STs and 13 years for OBCs who are PwBD). The persons claiming age relaxation under this sub-para would be required to produce a certificate in prescribed proforma in support of their claims clearly indicating

that the degree of physical disability is 40% or more. In any case, the appointment of these candidates will be subject to their being found medically fit in accordance with the standards of medical fitness as prescribed by the Government for the each said individual post.

c) The benefit of reservation under EWS can be availed after production of an income and asset certificate issued by the Competent Authority.

d) Maximum upper age-limit for NIFT employees may be relaxed upto five years or total length of service rendered (on regular and/or long-term contract basis) whichever is less. This is over and above the relaxation prescribed for SC/ST/OBC (NC) & PwBD.

6. Scheme of Examination

The selection process to the vacant posts may include written test and/or skill/competency test. The written test will be followed by Skill/ Technical Test of the selected candidates as applicable. The Institute reserves the right to admit only that many candidates as considered necessary for Skill/ Technical test based on the performance of candidates in the written test and/or skill/ technical test as the case may be.

7. HOW TO APPLY

7.1 Application forms can be downloaded from NIFT Kolkata website (<https://www.nift.ac.in/kolkata/careers>). Applications, duly filled in the prescribed proforma, should be addressed to the Joint Director, National Institute of Fashion Technology, NIFT Campus, Block-LA, Plot-3B, Sector-III, Salt Lake City, Kolkata-700106 and shall be submitted in a sealed envelope superscribed with "Application for the post of _____". Self Attested copies of relevant documents, certificates and testimonials as proof of Age/Date of Birth, Educational Qualifications, Caste, Experience, etc. should be attached with the application form. The Receipt of the Application Fees (if submitted online) or the Demand Draft drawn in favour of 'NIFT Kolkata' payable at Kolkata should be attached with the application form. The demand draft should not be tagged or stapled but should be pinned or clipped at the top of the application form. Applicant should mention his/her name and the post applied for at the reverse of the DD.

7.2 Those candidates who are employed in Government Departments and/ or PSUs/Semi Govt./Autonomous Bodies under Government should send their applications Through Proper Channel along with "No Objection Certificate" from their employer stating that the applicant if selected will be relieved within three months or earlier of the receipt of the appointment orders along with the vigilance clearance.

7.3 While applying for the posts of Machine Mechanic and Lab Assistant, Competency Code should be mentioned in the application form. The details of the competency code is mentioned in the Eligibility for the posts (refer Annexure-I & Annexure-II).

7.4 Only female candidates are eligible to apply for the post of Assistant Warden (Girls). Therefore, candidates applied for the post of Assistant Warden (Girls) need not to pay the application fee. (Applications received from the male candidates for the post of Assistant Warden (Girls) will be summarily rejected)

7.5 The candidates shall mention their correct and active e-mail addresses and Mobile number in their application form at prescribed place, as correspondences viz. call letters/ admit cards or any other information may be communicated through email.

7.6 Any updates with regard to this recruitment drive shall be published at NIFT Kolkata's website (<https://www.nift.ac.in/kolkata/careers>). The applicants are requested to follow our said website on regular basis for latest updates/ corrigendum/ addendum, if any.

7.7 The candidates who are in private university/ organization, who are eligible, need to submit an undertaking/self -declaration to the effect that – "No penalty has ever been imposed on him/her and he/she has never been convicted by any Court of Law".

7.8 Certificate in support of experience should be given by Appropriate Authority clearly mentioning the post and the period in that particular organization / Institution.

7.9 No TA/ DA shall be payable to any candidate for attending written/ skill test.

4. No correspondence will be entertained from the candidates regarding the eligibility, status of applications, postal delays, conduct and result of test etc. either before or after the selection.
