You are requested to kindly provide your quotations with best possible rates towards the AMC of above mentioned items. The quotation should be in a sealed cover and as per the following terms and conditions:

- 1. Rate should be quoted as per the format on Annexure-II and inclusive of GST.
- 2. Quotation should be sent in sealed envelope super scribing "Quotation for AMC of Water Coolers" on the envelope.
- 3. The L1 agency should submit the 5% of the contract value as a security deposit, within 01 week after accepting the work order.
- 4. The AMC comprises a total of 4 services per year including supply of all material spares, replacement /repairs of Coolers, Compressor repairing/ replacement, electrical parts, servicing, overhauling, wiring repairs, water lab test and parts replacement etc., complete in all respects, for ensuring the desired levels of water cooling. And cleaning, testing, readjusting, replacement of parts needed for proper operations for Comprehensive AMC of Water Coolers installed at NIFT Campus, Mumbai.
- The period of contract should be for a period of one year which may be extended further on the basis of performance.
- 6. The number of machines may increase or decrease and the same would be intimated to the agency accordingly.
- 7. The penalty amount per complaint will be as follow:
  - I) Fault not rectified within 48hour @ Rs 50/- per hour subject to maximum @ Rs. 5,000/-.

II) Major faults not rectified within 48 hours @ Rs 250/- per day subject to maximum @ Rs. 5,000/-.

III) Beyond 15 days, if the equipment is getting repaired in the open market and the actual cost of the repairs shall be recovered from the contractor. In extreme cases, the action of forfeiture of security money/pending bill/blacklisting of the firm can be resorted at the discretion of the competent authority.

- 9. Payments will be on quarterly basis against the submission of job completion report, original invoices and after verification by concerned NIFT Officials.
- 10. Before submitting the invoice the Service report has to be certified and signed by NIFT technician and Electrical Engineer- (Annexture-1)
- 11. The bidder should visit and inspect the water coolers installed at NIFT Campus, before submitting the quotation.
