For this purpose, NIFT invites e- Tenders from reputed agencies or contractors having experience of at least 04 years in the same field. The terms and conditions of the tender are as follows:-

Tenders are invited from reputed agencies or contractors, having experience of at least 04 years in the same field for "Providing Comprehensive Annual Maintenance Contract for Air Conditioners Installed at NIFT Campus, Plot no.15 & 20, Sector-4, Kharghar, Navi Mumbai.

- 1. Providing Comprehensive Annual Maintenance Contract for Air Conditioners Installed at NIFT Campus, Plot no.15 & 20, Sector-4, Kharghar, Navi Mumbai
- 2. As per the requirements and details enclosed from contractors or agencies who have carried out similar work.
- 3. NIFT shall have the authority to cancel the tender process if NIFT does not find a suitable tender. NIFT shall have the right to call for fresh tender in such circumstances, wherein tenderers who have bid in the previous tender, shall have the right to participate in the fresh process. The tenderers shall have no right to challenge the authority and decision of NIFT to cancel the tender process for the reasons deemed fit by NIFT.
- 4. The site can be inspected any time during working hours on any working days. No extra money shall be payable by NIFT for non awareness of the site conditions and constraints.

Submission of Bids

- (a) The interested agencies/contractors should apply online and submit their tender and the bids along with scanned copies of all the relevant certificates, documents, etc. in support of their technical & price bids – all duly signed – on the https://eprocure.gov.in from 08.12.2022 to 28.12.2022 up to 3.00 P.M. Tender documents is also available for viewing on the "tenders" link of the NIFT Portal & NIFT website i.e. <u>https://eprocure.gov.in</u> & <u>http://www.nift.ac.in/mumbai</u>.
- (b) Applications to this tender will be accepted only through the online mode through the website https://eprocure.gov.in. No other mode of application will be considered & application will not be accepted.
- (c) For applying online, the Firm should get itself registered at <u>https://eprocure.gov.in</u>.
- (d) The Firm should ensure that it complies with the requirements as per works before applying for tender.
- (e) The agency should apply/submit two separate bid, one for "Technical Bid" and another for "Financial Bid" in <u>https://eprocure.gov.in</u>. The technical bid must contain the details in prescribed Performa as per Annexure III along with a demand draft for Earnest Money Deposit (refundable but non-interest bearing) (EMD) of Rs. 27,000/- (Rupees Twenty Seven Thousand Only, exempted for MSME/Udyam) favoring National Institute Of Fashion Technology and payable at Mumbai payable infavour of "NIFT MUMBAI" or thru NEFT/RTGS at "NIFT Mumbai, IDBI Bank, Account no. 0302104000145176, IFSC IBKL0000302" (with intimation at admin.mumbai@nift.ac.in) with all relevant documents in support of eligibility and experience criteria. The financial bid must contain only the financial bid-VIII. The financial bid shall include all the charges including all taxes etc to complete the work in all respect. NIFT will not accept any claim other than mentioned in financial bid.
- (f) The technical bid will be opened in e-tender portal on 29.12.2022 at 03.00 P.M. The Financial bid will be opened subsequently only those bidders who are found to be technically qualified after evaluation of technical bids by a committee.
- (g) The interested firms are advised to read carefully the entire tender document before submitting their tender and the tender documents not received online in prescribed format and/or are found incomplete in any respect shall be summarily rejected.

- 1. The tenders shall submit the offer duly signed on all pages and sealed.
- 2. Tenders **in two bid systems** are invited on behalf of the National Institute of Fashion Technology, Mumbai from manufacturers/Authorized sale/ service dealers of reputed companies & who have worked with PSU's Govt./Pvt. MNC's reputed agencies, which have carried out similar works as per the requirements and details as given below.
- 3. Tender shall be submitted in official tender form only. If submitted in any other form the same shall be summarily rejected.
- 4. Tenders received without prescribed earnest money before the last date of submission of Tender shall not be considered.
- 5. The schedule issued with the tender listing the details of items to be supplied must not be altered by the tenderer. Any modifications/alterations of the schedule considered necessary by the tenderer, should be in the separate letter accompanying the tender.
- 6. The name and address of the tenderer shall be clearly written in the space provided and no overwriting, correction, insertion shall be permitted in any part of the tender unless duly countersigned by the tenderer. The tender should be filled in and submitted in strict accordance with the instructions laid down herein: otherwise the tender is liable to be ignored.
- 7. The tender is liable to be ignored if complete information is not given there-in, or if the particulars and data (if any) asked for in the schedule to the tender are not filled in online submission and hard copies.
- 8. Individual signing the tender or other documents connected with the tender must specify whether he signs as
 - (i) A sole proprietor of the concern or constituted attorney of such sole proprietor.
 - (ii) A partner of the firm if it is a partnership firm, in which case he must have authority to execute contracts on behalf of the firm and refer to arbitration disputes concerning the business of the partnership either by virtue of the partnership agreement or by a power of attorney duly executed by the partners of the firms.
 - (iii) Director or Principal Officer duly authorized by the Board of Directors of the Company.
 - (iv) In case of (i) a copy of the partnership agreement or general power of Attorney, in either case attested by a Notary Public should be furnished

or an affidavit on stamp paper duly sworn or affirmed by all the partners admitting execution of the partnership agreement or the general power the business of the partnership has been conferred on any partner, the tender and all other related documents must be signed by all the partners of the firm. In case of (ii) the person signing the tender should be authorized by a resolution passed by the Board of Directors and a copy of the resolution attested by the Principal Officer should be attached.

- (v) Annual Turnover for the last three years not less than 40 lakhs for each year i.e 2019-20 (not less than Rs. 40 Lakh), 2020-21 (not less than Rs. 40 Lakh) and 2021-22 (not less than Rs. 40 Lakh).
- 9. Tender shall be accompanied by the relevant documents including the Following:-
 - I) Certificate in support of experience for having undertaken this kind of business along with a list of organizations where the Contractor is currently providing/has provided AMC of Window AC & Split AC covered in the tender.
 - II) Copy of GST Firm Registration.
 - III) Copy of the PAN no. of the Firm.
 - (IV) List of Present Clients.
 - (V) List of Past Clients during last three years.
- 10. The bids should be valid in the case of all the tenders for at least 4 months from the date of opening of the tender. In the case of the successful tenderer, rates quoted shall be valid for the entire period of the contract.
- 11. National Institute of Fashion Technology reserves the right to accept or reject any or all the offers either fully or partly without assigning any reasons and is not bound to accept the lowest bid since due weight age shall be given to several factors besides the commercial bid.
- 12. The contract once awarded can be terminated by either party after giving one month notice to the other party. Nevertheless, NIFT may terminate the contract of contractor without any notice in case the contractor commits a breach of any of the terms of the contract; NIFT's decision that a breach has occurred will be final and shall be accepted without demur by the Contractor.
- 13. NIFT shall in no way be responsible for any default with regard to any statutory obligation and the Contractor will indemnify NIFT in case of any damage or liability, which may arise on account of action of contractor.

14. Dispute, if any, arising out of the contract shall be settled by mutual discussion or arbitration by sole arbitrator to be appointed by the Director, NIFT, Navi Mumbai as per the provisions of the Indian Arbitration and Conciliation Act, 1996 and the Rules framed there under. Any Arbitrator appointed shall not have the jurisdiction to pass any interim awards, or to grant interest higher than 8% charged simply on the award amounts, or amounts payable to either party.

General Terms and Conditions for Air Conditioner

- 1) Comprehensive AMC of Window, Split, Tower AC's shall include supply of all material spares, replacement of compressor, Fan Motor , other parts from Original Equipment Manufacturers, gas charging, air filter, electrical parts, servicing, overhauling, greasing, starting relay, overload protector, wiring repairs, tapes including handling charges, blower motor/outdoor fan motor, remote set repairs, digital scanner, piping insulation and spares of outdoor/indoor units replacement etc., complete in all respects, for ensuring the desired levels of cooling.
- 2) During the period of contract, company will be responsible for proper and consistent functioning of all the air conditioners.
- 3) In case any machine goes out of order, the repair work should be carried out by the company in the NIFT premises. Only such work, which cannot be executed in the NIFT premises, will be allowed to be carried out in the workshop of the company with the prior permission of NIFT for which no extra charges like cartage, transportation etc. will be paid. The maximum period for repair at workshop shall be five days. Beyond the stipulated period a penalty of Rs.500/- (Rs Five hundred only) plus GST 18% per day shall be imposed and shall be recovered from the bill of subsequent quarter.
- 4) Till the time AC in repaired the contractor will provide a standby AC in running condition.
- 5) Dismantling/relocation of window/Split Air conditioner shall be considered in the quoted rates of AMC; however, the cost of refrigerant Gas, insulated refrigerant piping, interconnection cables and drain pipe will be paid extra as per below mentioned rates:

- 6) The contractor shall ensure that all air conditioners are in proper working conditions throughout the contract period.
- 7) Deployment of staff by the Contractor:

(From Monday to Saturday 9 AM to 6 PM*):-

- 8) Complaint / Feedback / Performance report: The Contractor will maintain all records of the complaints in a Register. The format of the register is enclosed as Annexure I.
- 9) The contractor will maintain preventive maintenance record of equipments under maintenance contract in a Register. The format of the register is enclosed as Annexure II.

- 10)Any damage to the building or the any part of the equipment which might result during the operation shall be repaired by the contractor.
- 11)Contractor will provide mobile numbers of Mechanic to Building Department before start of the AMC work.
- 12)Any damage resulting to the system on account of the negligence or malloperation shall be made good by the contractor. Nothing extra will be paid for such work.
- 13)The contractor shall arrange to render efficient service as outlined in this specification. However, in case the contractor fails to maintain the service to the satisfaction of the Stakeholders and any expenditure incurred therein for alternative arrangements by the Building Department shall be recovered from the contractor.
- 14)Contractor has to provide adequate / additional staff within their quoted amount during servicing of Air Conditioners as prescribed in scope of service.
- 15)NIFT would be justified in asking for replacement of any of the contractor's staff. The decision of the NIFT in this regard will be final.
- 16)NIFT reserves the right to verify the qualifications, work experience and confides of the contractor's staff.
- 17) The contractor would ensure that his staff must have Identity cards to enter the premises of the NIFT Mumbai for due performance of duties.
- 18)The staff provided by the contractor will be disciplined, polite and courteous and will not misbehave with any of the NIFT staff members and will not enter into any unlawful activities in the premises.
- 19)The contractor and his staff abide by the regulations / requirement of security dept. and strictly follow the rules.
- 20)NIFT's security staff will have right to check, search or interrogate any of the contractor's staff while entering / leaving the NIFT premises for security purposes.
- 21)The contractor is required to make arrangement to provide to their mechanic with the tool kit, welding set, and hammer / drill machine or required

accessories etc. to carry out subject work. No AC should be non functional/ Shut down at any point of time.

22)The contractor is required to maintain the adequate stock of the consumable material such as gas, air filter, electrical parts, grease, starting relay, overload protector, wires, tapes, blower motor/outdoor fan motor, remote set, digital scanner, piping insulation and spares of outdoor/indoor units at adequate quantity.

23) PERFORMANCE SECURITY

- i) The contractor shall be required to deposit an amount equal to 8% of the tendered value of the contract as Performance Security within the period prescribed for commencement of work in the Letter of Award issued to him. Performance security may be accepted as Bank Guarantee of Scheduled Banks and State Bank of India or in the form Demand draft in favour of NIFT or thru NEFT/RTGS at "NIFT Mumbai, Account no. 0302104000145176, IFSC IBKL0000302" (with intimation at admin.mumbai@nift.ac.in).
- ii) This guarantee shall be in the form of fixed deposit receipts pledges in favour of the Employer or Bank guarantee of Scheduled Banks or State Bank of India in accordance with the Proforma attached. In case fixed deposit receipts of any bank are furnished by the contractor to Employer as part of the Performance Security and Bank is unable to make payment against the said Fixed Deposit receipts, the loss caused thereby shall fall on the contractor and the contractor shall forthwith on demand furnish additional security to the Employer to make good the deficit.
- iii) The contractor will be be allowed to start the work unless the Performance Security/Guarantee is submitted by him. In case of failure by the contractor to furnish the Performance Security/ Guarantee within specified period, Employer shall without prejudice to any other right or remedy available in law, be at liability to forfeit the Earnest Money absolutely.
- iv) The Performance security shall be initially valid upto 60 days after recording of satisfactorily completion of work by the Employer. In case the time of completion of work gets and enlarge, the contractor shall get the validity of Performance Security extended to cover such enlarge time for completion of work on 60 days of recording of satisfactory completion of work by the Employer, the Performance Security shall be returned to the Contractor, without any interest.

SCOPE OF SERVICE

The scope and nature of services to be provided by the contractor shall include scheduled preventive maintenance services which cover periodic and break down servicing, along with **replacement of defective spare parts with new and genuine one, including Compressor, Fan Motor and other consumables,** if required during the contract period. The routine maintenance service which shall include at least the following services:

Half Yearly Checklist for AC units: (In addition to Quarterly activities)

Above mentioned checklist should be submitted to engineer incharge invariably. Report to the Engineer In charge in writing of all defect/ deficiencies and make repairs.

- 1 Immediately attending to any breakdown call made on receipt of verbal / written complaint during office hours on all working days. The time for rectification of defect shall not exceed 24 hours in any case.
- 2 Providing a service unit, free of charges during the repair of AC unit in the workshop.
- 3 Supply free of charges, of all the spares and materials including consumables, compressor found defective and necessary for the unit.
- 4 The servicing and maintenance shall be carried out without disturbing the normal functioning of the office,
- 5 The filters shall be cleaned on weekly basis and record thereof shall be maintained.
- 6 The history sheet of servicing/breakdown repairing of each and every unit shall be maintained. The copy of report shall be submitted along with the bill subsequent to the servicing activity. The cleaning/ minor repair of stabilizers shall be covered under the AMC contract.

- 7 If the contractor fails to maintain the required manpower, NIFT is empowered to deduct penalty at the rates indicated below from their bill: Mechanic Rs.500/- plus GST 18% per day (Applicable also in case late/part absent).
- 8 The contractor will provide required man power to work on holidays in case of need for which no extra payment shall be made.
- 9 Daily attendance and complaint register must be maintained and will be produced before the Building Department.
- 10 The contractor shall be wholly responsible for theft, burglary, fire or any other mischievous done by his staff.
- 11. The Contractor will work in close co-operation with Building Dept, NIFT for the Repair & Maintenance services as per tender.
- 12. Payment shall be made quarterly on satisfactory completion of the job and/ submission of bill. TDS as applicable will be deducted.
- 13. All statutory obligations under various laws from time to time will have to be borne by contractor for which no extra payment shall be made to him at any time during the contractual period.
- 14. The contractor shall at all times indemnify and keep indemnified the owner and its officers, servants and agents from and against all third party claims whatsoever (including time not limited to property loss and damage, personal accident, injury or death of/or property or person of any sub-contract and or the servants or agents of the contractor any sub-contractor(s) and or the owner and the contractor shall at his own cost and initiative at all times, maintain all liabilities under Workman's Compensation Act/Fatal Accident Act, Personal Injuries, Insurance Act and/or their Industrial Legislation from time to time in force.
- 15. As per NIFT policy, payments and receipts to Government and Semi Government Agencies would be rounded off to the nearer higher rupee and in other cases the rounding off will be to nearest i.e. paisa 50 or above will be rounded off to the near higher rupee and paisa less than 50 will be ignored.
- 16. The agreement will be valid for Comprehensive AMC of Split & Window AC units as incorporated in the contract document. This should be strictly adhered to.

- 17. In case the amount quoted by lowest two or more bidders is similar then criteria of Turnover will be considered for the award of Tender.
- 18. The rates quoted should be inclusive of all taxes and including GST.
- 19. The rates quoted should be on FIRM & FIXED basis.
- 20. Comprehensive AMC of Split & Window unit AC's including supply of all material spares, replacement /repairs of compressor from OEM's, gas charging, stabilizer, air filter, electrical parts, servicing, overhauling, greasing, starting relay, overload protector, wiring repairs, motor rewinding with bush and shaft, tapes including handling charges, blower motor/outdoor fan motor, remote set repairs, digital scanner, piping, insulation and spares of outdoor/indoor units replacement etc., complete in all respects, for ensuring the desired levels of cooling.
- 21. AMC shall also include deployment of full time mechanic (Mechanic -02 no's required at full time) (from 09.00Am To 6.00PM every day (Monday to Saturday) including holidays at no extra charges. He will report to NIFT-Electrical Engineer for daily attendance and will take necessary instruction for effective co ordination, fault analysis and trouble shooting.
- 22. A minimum stock of spares including compressors, fan & blower motors, fan blades & accessories etc. will have to be maintained at the premises for meeting immediate exigencies of work and upkeep of equipments at all times. Efforts should be made to ensure close to zero MTBF (Mean Time between Failures).
- 23. Contractor has to do quarterly service of the unit by trained personnel including the following:
 - a) Rectification of defects observed during inspection.
 - b) Checking of electrical parts including motors & rectification.
 - c) Checking & adjustment of controls and lubricating of moving parts.
- 24. The rates shall be submitted in the prescribed Performa Annexure enclosed.
- 25. After awarding the contract on the term & condition mentioned in the tender document if a contractor decline to offer service during the contract period EMD/Security deposit /performance guarantee will be forfeited.
- 26. The penalty amount per complaint will be as follow:

I) Fault not rectified within 6hour @ Rs 100/- plus GST 18% per hour.

II) Major faults not rectified within 48 hours @ Rs 500/- plus GST 18% per day.

- III) If OEM or above specification component is not used as maintenance spare, the cost of the equipment will be paid by the vendor if the equipment becomes unserviceable.
- IV) Any delay beyond 10 days in rectifying the major fault, the penalty will be enhanced to Rs-3000/- plus GST 18% per day.
- V) Beyond 15 days, if the equipment is getting repaired in the open market and the actual cost of the repairs shall be recovered from the contractor. In extreme cases, the action of forfeiture of security money/pending bill/blacklisting of the firm can be resorted at the discretion of the competent authority.
- 27. Details of all minor/major, routine/preventive repair/maintenance job undertaken shall be entered into the history sheet.
- 28. Complaint feedback/performance report:- The Contractor will maintain all records of the complaints in a Register to be provided later by the Engineer-in-Charge.
- 29. After completion of the Agreement, contractor has to hand over the system in perfect running condition (complete in all respects as per inventory) to the department.
- 30. Any damage to the building or the any part of the equipment which might result during the operation shall be repaired by the contractor.
- 31. In case the Mechanic is found absent from his duty, recovery at the rate of Rs.500/- per day shall be made from the contractor's bill.
- 32. Mechanic should have his Mobile Phone at the time of Duty at NIFT.
- 33. NIFT shall in no way be involved in any dispute of whatever kind, between the contractor and the staff engaged by him.
