# DIPLOMA PROGRAMME ADMISSIONGUIDELINES/PROCEDURE Academic Year: 2023-24 (For Mumbai Campus)

- 1. Submit the Diploma Programme Admission Form, along with the passport size photograph pasted in the specified area.
  - (Download application form from <a href="https://nift.ac.in/mumbai/continuing-education">https://nift.ac.in/mumbai/continuing-education</a>

Registration can be done manually by downloading the registration form available online. The completed filled in registration form/printout of the filled-in registration form, complete in all respects should be submitted only at the NIFT Mumbai Campus by the candidate by post/courier super scribed "DIPLOMA PROGRAMME" Registration form:2023-24" along with Demand Draft or Online payment details (online is preferable).

- Submit the Admission Form along with photocopies of the Qualification certificates (must be self-attested).
   The eligibility criterion for all the Diploma Programmes are 10+2 minimum education.
- 3. DEMAND DRAFT or ONLINE PAYMENT FOR REGISTRATION

The application fee can also be paid through DD / online net banking /NEFT/ RTGS/IMPS in NIFT Mumbai bank account.

All demand drafts have to be drawn in favour of "**NIFT MUMBAI**" payable at Mumbai.

#### 5. PERSONAL INTERVIEW

On successful receiving the serial No.1,2,3,4 - The Interview panel/course coordinator at NIFT Mumbai will conduct a personal interview (or any other format for selection criteria) with the candidate. (It is on the discretion of coordinator, Personal Interview can also be conducted through online due to COVID 19 pandemic). The date of the interview will be intimated to the candidate by the respective CE Programme coordinator over telephone/E-mail id.

A candidate is judged on the various parameters as listed below by an interview panel in the personal interview:

- Career orientation
- Aptness for the field
- Overall personal achievements in academics and co-curricular activities.
- Communication
- General awareness and aptitude, creative and lateral thinking are likely to be useful.

During interview the candidate should show their original certificates to the course coordinator.

The candidates will be selected on provisional basis and final selection will be after the verification of the original certificates by the course coordinator, before the course commencement date.

#### 6. COUNSELING:

The details of Interview result will be informed personally in an E-mail.

After the selection in the Diploma Programme, the candidates need to pay the full course fee. Also resource center fee may be paid.

- 8. Candidates appearing in the qualifying examination such as 12th class/final year/final semester (as the case may be mentioned in eligibility criteria) are also eligible to apply to Diploma Programme provisionally, subject to the following conditions:
  - Those candidates who are seeking provisional admission due to nondeclaration of their qualifying examination will provide proof of having passed all papers in all the previous year's /semesters (whichever relevant).
  - The candidate will submit the final result of qualifying degree/certificate providing his/her eligibility as and when the results are declared, to their Diploma Programme coordinators at college Campus, where the admission has been granted on or before the commencement of the course or before issuing the Diploma Programm certificate.
  - In case student attends a programme but fails to qualify the qualifying examination no certificate will be issued and no course fee will be refunded.
