The Students are required to pay the applicable fee as per the schedule mentioned below and to note the NIFT rules on non-payment and re-registration.

- 1 Last date of depositing the fees for the session Jan. - June. 2023 is 15th February, 2023. Fee with a late fine of Rs. 100/- per day plus GST@ 18% can be deposited till 28th February, 2023.**
- 2. The name of the student will be struck from the institute rolls without any further notice in case of non-payment of fee after the specified date. and will have to register himself / herself by paying registration fee of Rs. 10,000/- + 18% GST = 1,800/- = Total Rs. 11,800/- over and above the applicable semester fee. NIFT Patna will not intimate students individually. It is the sole responsibility of the student to pay fees as per the notification received from HO.**
- 3. Students will be required to pay their current semester fees (Tuition Fee) through CMS Payment Gateway only (as per information provided above). The student who has availed bank loan/scholarship facility may contact accounts department of the campus for further details.**

4. Students rejoining to repeat the semester and those rejoining after availing Leave of Absence are requested to contact their Department before the commencement of the session and to complete the formalities. Repeat students will be required to pay the re-registration fee of **Rs.10,000/- + 18% GST = Rs. 1,800/- = Total Rs. 11,800/-** per absenting semester as well as non-refundable annual charges towards Library and Student Development & Medi-claim fee over and above the mentioned amount.
5. The students who has **availed bank loan/scholarship facility** may contact account department of the campus for further details
6. The student has to mandatorily submit transaction details in the prescribed format along with transaction receipt to email id - feedeposit.patna@nift.ac.in & concern department. The format is uploaded on the website with this circular.
