

It is requested to note the following:

1. Last date of depositing the fees for the session July 2021 to Dec. 2021 is **15th September, 2021**. Fee with a late fine of Rs. 100/- per day plus GST@18% can be deposited till **29th September, 2021**.
2. **The name of the student will be struck from the institute rolls without any further notice in case of non-payment of fee after the specified date. NIFT Patna will not intimate students individually. It is the sole responsibility of the student to pay fees as per the notification received from HO.**
3. **Students will be required to pay their current semester fees (Tuition Fee) through CMS Payment Gateway only (as per information provided above).** The student who has availed bank loan/scholarship facility may contact accounts department of the campus for further details.
4. **PG Students of 3rd Semester will be required to pay the Alumni Association Membership fee (one time) (Non Refundable) of Rs. 4,800/-**





5. Students rejoining to repeat the semester and those rejoining after availing Leave of Absence are requested to contact their Department before the commencement of the session and to complete the formalities. Repeat students will be required to pay the re-registration fee of Rs.10,000/- + 18% GST = Rs. 1,800/- = **Total Rs. 11,800/-** per absenting semester as well as non-refundable annual charges towards Library and Student Development & Medi-claim fee over and above the mentioned amount.

6. **The students who has availed bank loan/scholarship facility** may contact account department of the campus for further details and may instruct their banker/scholarship sanctioning authority to remit fee in the following manner [either option (a) or option (b)]:

(a). Pay current semester fee (Tuition fee) through Demand Draft (in favour of "NIFT, Patna", payable at Patna).

(b).
