The Selection Process to the above posts will include written test and Skill / Competency test. The selection of the candidates shall be purely on merit list. The merit list will be drawn on the basis of Written-Test & Skill-Test (whichever applicable).

In case of EWS category candidates seeking benefit must submit income proof issued by appropriate authority. The benefit of reservation under EWS can be availed upon production of an income and asset certificate issued by a competent authority. The income and asset certificate issued by any one of the following authorities in prescribed format shall only be accepted as proof of candidates claims belonging to EWS;
  - i) District Magistrate /Assistant District Magistrate/Collector/Deputy Commissioner/Additional Deputy Commissioner/Ist Class Stipendiary Magistrate/ Sub- Divisional Magistrate/Taluka Magistrate/Executive magistrate, Extra Assistant Commissioner.
  - ii) Chief Presidency Magistrate/Additional Chief Presidency Magistrate/Presidency Magistrate.
  - iii) Revenue officer not below the rank of Tehshildar and
  - iv) Sub – Divisional officer or the area where the candidate and /or his family normaly resides.
16. The institute shall verify the antecedents or documents submitted by the candidates at any time during the tenure of service. In case if it is detected that the documents submitted by the candidates are fake or the candidates has a clandestine antecedents/background for which he/she has been convicted by any court and has suppressed the said information, then his/her candidature/ will be canceled/services shall be terminated forthwith and appropriate action will be taken.
17. Any form of canvassing will lead to disqualification of the candidate.
18. No TA/DA shall be payable to any candidate for attending written/ Skill/ Competency test.
19. In case of any dispute, the decision of the Director, NIFT Patna shall be final. No application under RTI Act 2005, shall be entertained during the entire recruitment process.
20. Persons with disabilities (PWD) fulfilling the eligibility conditions are encouraged to apply. Reservation for persons with disabilities (PWD) shall be observed as per the Govt. of India guidelines.
21. NIFT Administration reserves the right to cancel or postpone the recruitment at any point of time.
