**2. Process of Selection:**

The selection for the post shall be based on the academic credentials, experience, and performance in the interview. The selection committee shall be empowered to devise the selection criteria as deemed appropriate.

### 3. Important Instructions:

1. The applicant must be a citizen of India.
2. The post is to be filled on a Short-Term Contract basis only for a period of six months.
3. The selection for the post shall be based on the suitability of the candidate for the position, which shall be determined by NIFT Patna in a fair and transparent manner.
4. The prescribed qualifications are minimum. Mere possession and fulfillment of the essential qualifications and experience may not entitle a candidate to be called for the selection process. No correspondence will be entertained from the applicant either before or after the selection. The decision of NIFT shall be final and binding on all the candidates.
5. Incomplete applications or applications received without a photograph, attested copies of required certificates such as educational qualifications, caste/community/experience, etc., and those received after the prescribed last date will be summarily rejected without any communication to the candidates. No further correspondence will be entertained in this regard.
6. Applicants must fulfill the essential requirements of the post and other conditions stipulated in the advertisement as of the last date of receipt of applications. They are advised to satisfy themselves before applying that they possess at least the essential qualifications and experience laid down for the post as of the last date of receipt of the applications. No inquiries with reference to eligibility will be entertained.
