4. SELECTION CRITERIA OF BIDDER

The selection of eligible bidder will be based as per following terms & Conditions:

Technical Bid: The financial bid will be opened only of those bidders who will qualify technical bid.

Financial Bid: Work order will be awarded to the L1 bidder who will quote lowest rate for overall work in Indian Rupees (INR).

In case L-1 is more than one, then the overall average turnover of last 03 years i.e. 2022-23, 2023-24 and 2024-25 of the bidders on higher side would be the selection criteria. Selection of successful bidder by NIFT Authority in such situation will be one of the final in all respect and will be binding on all the bidders.

5. DOCUMENTS REQUIRED

Tender shall be accompanied by the relevant documents with Technical Bid (**Annexure-I**) duly certified by the firm: -

- (I) The average turnover for financial year i.e. 2022-23, 2023-24 and 2024-25 of the bidding firm should be at least Rs. 17 Lakh (Seventeen Lakh Only). - (III) **Profit/loss:** The bidder should not have incurred any loss (profit after tax should be positive) in more than two years during available last five consecutive balance sheet, duly audited and certified by the Chartered Accountant. "Balance Sheets along with Statement depicting Profit/Loss for the each of the three financial years (i.e. 2022-23, 2023-24 and 2024-25) duly certified by Chartered Accountant should be enclosed.

1. The rates shall include cost of labours, transport & material for the works complete in all respects.
2. The quoted rates shall include all taxes and GST as applicable and no extra amount shall be payable on this account.
3. Rates shall be valid for six months from the date of opening of financial bid.
4. Water and Electricity will be provided free of cost at one point for Bonafide use.
5. **Whole Work shall be completed within 75 days from the date of issue of the work order.**
6. The selected contractor/agency shall have to furnish one-year guarantee against any defects/leakage. The sample and brand must be approved by NIFT before commencement of the work.
7. Works are to be carried out as per CPWD specifications.

8. Security deposit of 5% of total Work Order will be deposited in the form of Demand Draft in the name of "NIFT Raebareli" payable at 'Raebareli' within seven days after issue of Work Order. However, EMD amount can be converted to security deposit. The same shall be released after completion of fifteen months from the date of handing over of completed work.
9. If the performance of the contractor is not found satisfactory and not corrected within 15 days of receiving notice, then NIFT shall be at liberty to terminate the contract and get the work executed through other means at the risk and cost of the Contractor. In the event of termination of the contract, NIFT shall be at liberty to get balance work done at the risk and cost of the contractor and due payment of the contractor, if any, shall be released after the completion of whole of the works.
10. If the contractor fails to maintain the required progress of work or fails to complete the work by the stipulated / extended date of completion then the delay damages shall be levied @ 0.5% of the tendered amount per week, subject to a maximum of 10% of the tendered value.
11. Any dispute arising out of this tender is subject to the jurisdiction of Raebareli Court only.
12. Payment will be made through NEFT only. The required information for making payment through NEFT duly vetted by banker along with the invoice.
13. No escalation/Variation on the prices on any account will be considered for adjustment/payment.
14. The color and brand/make/specification of the material used may be decided by the Competent authority of NIFT before execution of the works. The L-1 bidder must ensure final approval from the NIFT authority before executing the work with respect to the color, brand/make items and material etc. to be used in the said work.
15. The bidder shall inspect the site of work and thoroughly familiar himself with the nature of work, site conditions and access to the site and location before submission of the tender.
16. Proper care should be taken to provide adequate protection to the existing structures and cables (Telephone, computer etc.), all such installations against any damage/defect to the existing structure arising due to faulty execution of work shall have to be rectified as directed to the satisfaction of Engineer In Charge without any extra charges.
17. **Quality control:** Regular appraisal of the quality control to the Engineer – in-Charge should be made for effective improvement in the construction / painting techniques to ensure satisfactory quality of work.
18. National Institute of Fashion Technology, Raebareli reserves the right to accept or reject any or all the offers either fully or partly without assigning any reasons and is not bound to accept the lowest bid since due weightage shall be given to several factors (as shall be decided by NIFT) besides the commercial bid.
19. In case L-1 is more than one, then the overall average turnover of last 03 years i.e. 2022-23, 2023-24 and 2024-25 of the bidders on higher side would be the selection criteria. Selection of successful bidder by NIFT Authority in such situation will be one of the final in all respect and will be binding on all the bidders.
20. Conditional Bids/Vague offers like "Duties as applicable" shall not be considered.
21. NIFT, Raebareli reserves the right to cancel the bid if it considers that there is a cartel formation and that it is in overall interest of NIFT.
22. If the work is not executed after accepting the same, earnest money (EMD) will be forfeited in full and work will be got executed at firm's risk from some other firm. The firm shall also be liable to be blacklisted as per Government norms.
23. The work should be according to the specifications provided in the tender document. If the work is not executed as per specifications, suitable deductions will be made or the order shall be rejected by NIFT, as the case may be, at the cost of firm's risk.
24. Condition beyond control of either parties like war, hostility, acts of public enemy, civil commotion, sabotage, serious loss or damage by fire, explosions, epidemic, strike, lockout or acts of God come under the legal concept of Force Majeure (FM), Delays in performance of contractual obligations under influence of FM conditions are condonable by the other party without any right of termination or damages, provided notice of the happening of any event is given by the affected party to the other

within 07(Seven)days from the date of occurrence works under the contract shall be resumed as soon as practicable after such event has come to an end or ceased to exist. However, if such event continues for a period exceeding 120 days, either party may at its option terminate the contract by giving notice to the other party.

25. The materials supplied and proposed to be used in the work shall be of requisite make as specified in Annexure - IV. In the event a specific make is not available in the Annexure - IV, the makes provided in the approved Make List shall be followed. In the absence of both, the decision of Engg-In-Charge shall be final and binding.
26. Before starting the work, agency has to be supplied the entire material (Paint, Primer, Putty, cement etc.) at site and works will be start only after verification of the entire material.
27. Party must ensure that after painting the floor must be cleaned.
28. The exterior painting is to be carried out upto the height of Ground to G+6 .
29. The quantities of work given in the Bill of Quantities (BOQ), Annexure - II are approximate and are intended to provide a general idea of the scope of work. The work shall be carried out as per the approved design / specifications. The actual quantities may vary, either on higher or lower side and the contractor shall be obligated to execute the varied quantities at the quoted rates. Payment shall be made based on actual measurements of work executed at site. The Contractor shall be solely responsible for ensuring the safety of all workers engaged by him at site and shall strictly adhere to all applicable safety norms, standards and regulation prevailing in the industry.

6. CONCILIATION & ARBITRATION

- (i) If any dispute(s) or difference(s) of any kind whatsoever arise between the parties, the parties hereto shall negotiate with a view to its amicable resolution & settlement through a Committee appointed by Director – NIFT Raebareli Campus.
- (ii) In the event no amicable resolution or settlement is reached between the parties within 30 days after receipt of notice by one party, then the disputes or differences as detailed above shall be referred to & settled by the sole Arbitrator to be appointed by Director – NIFT Raebareli Campus.
- (iii) The Arbitration proceedings shall be in accordance with the provision of the Arbitration & Conciliation Act, 1996 & Laws of India as amended or enacted from time to time.
- (iv) The venue of the Arbitration shall be based upon the NIFT Raebareli. The language of the arbitration proceedings shall be in English.
- (v) The Arbitrator will give the speaking & reasoned award.
