#### A) BACK GROUND

#### ABOUT NIFT

National Institute of Fashion Technology (NIFT), set up in 1986 under the aegis of Ministry of Textiles, Government of India, is a Statutory Institute Governed by the NIFT Act 2006. The 3 decades history of the institute is built on the foundation of core values to nurture academic excellence. Ranked consistently as India's premier institute in fashion education, its focus is on integrating and balancing innovation in technology with traditional craft heritage through invigorating thought leadership, research stimulus, industry focus and creative enterprise which have contributed to its distinctive academic repertoire. The curricular thrust and pedagogic practices of NIFT have been instrumental in its pre- eminent status as a beacon of serious critical engagement, and a key enabler in developing competent professionals. The periodic upgradation of the curriculum addresses and incorporates the current issues and challenges of the fashion industry fostering innovative thinking with associated skills are testimony to its global standing among peer institutes.

NIFT Shillong started its operations in the year 2008 and is presently running 2(two) Undergraduate and 1(one) Postgraduate programmes.

#### B) SCOPE OF WORK

NIFT - Shillong conducts various campus related events like spectrum and convocation whose description is given below:

**SPECTRUM** has been a pursued legacy of NIFT and provides a platform to students from different institutions to showcase their talents across different genres. The annual fiesta promises high-quality competitions in events ranging from Quizzes, Debates, Fun Games, Street Plays, etc. This two-day event is one of the most awaited festivals of the year and is held in the month of February.

**NIFT Annual Convocation** is an annual event in which degrees are awarded to the final year students from disciplines and each of the disciplines are required to conduct their own events in which students showcase their presentation by means of Fashion Shows, Exhibitions and Seminars etc. The same is held in the month of May.

The events list mentioned above are not an exhaustive list as various other events are organised from time to time depending on the mandate given NIFT Head Office, New Delhi

NIFT Shillong therefore invites various government/quasi government agencies/vendors to conduct such events at Institutional and Domestic levels. NIFT proposes to empanel organizations of repute for executing such events on turnkey basis.

The scope of work will include following:

- Show Production including conceptualization, organization and management of events (Fashion Shows, Exhibitions and Seminars etc)
- Designing and Erecting temporary Stage/ Ramp/ Green Rooms/ Backdrop
- Providing creative inputs in designing of Fashion Shows/Exhibition/Seminars etc space including preparation of display material, models, stimulations, etc.
- Taking up all the steps of designing, erecting, setting up and dismantling of exhibition space and structures
  of events.
- Taking up necessary fabrication according to the designs and space layout at the exhibition and events.
- Decoration and maintenance of exhibition stalls, pavilions and event places.
- Designing & Fabrication of display boards and other signage.
- Preparation of tableau, mobile exhibition units, road shows displays, etc.
- Any other related services on mutually agreed terms related to creative display

- Printing including digital printing, electrostatic printing, embossing, letterpress, offset lithography, screen
  printing, printing of invitation cards for various functions and social occasions, conference note pads,
  information booklets about the conference, parking labels for various venues, mini booklets for programs,
  files/ folder covers, letter heads, delegate's bags/ folders etc.
- Documentation including photography and videography of the Events including in digital form.
- Show script and professional compering
- Arranging transport and logistics, lodging with provision of cars, mini bus and buses, as the case may be. The
  quality of vehicles and staff should be commensurate with the national stature of the event.
- Organising press conferences, press release and media coverage of the conference.
- Light and Sound design with operation
- · Audio-visual setup with Screen and live projection

#### C) TECHNICAL ELIGIBLITY CRITERIA

- 1. The Agency/Company/Firm/Institution/Organization should be registered with appropriate Government Authority and have been organizing event management services for a minimum of 03 years prior.
  - a. The Agency/Company/Firm/Institution/Organization should have an average annual turnover of the last 03 Financial Years i.e. FY 2014-15, FY 2015-16 and FY 2016-17.
  - b. For the empanelment of Category A. International/National Level Rs. 1 Crores
  - c. For the empanelment of Category B. Institutional/State Level Rs. 10 Lacs
- 2. Agency should have conducted a minimum o3 Events/Seminars/Exhibitions/Shows for the category applied for, in last o3 years as the minimum technical criteria for empanelment in the respective category.
- 3. The Agency/Company/Firm/Institution/Organization **should not** have been blacklisted by Central or any State Government or Government Organization/ Agency/Institution. An undertaking may be provided for the same.
- 4. The Agency/Company/Firm/Institution/Organization should have copy right license, broadcasting license from appropriate Government Authority.
- 5. PAN issued by the Income Tax department in favour of the Agency/Company/Institution /Organization.
- 6. GST Registration number issued by the Central Excise Department in favour of the Agency/Company/Institution/Organization.

#### D) GENERAL CONDITIONS

- NIFT reserves the right to disqualify any Agency/ Company/ Institution/ Organisation from the empanelled list, if the service provided by the Agency/ Company/ Institution/ Organisation is found to be unsatisfactory or if the information provided for empanelment is found to be false.
- 2. NIFT reserves the right to reject any application for empanelment without assigning any reason.
- 3. The Agency/ Company/ Firm/ Institution /Organisation may submit application for empanelment for any one the category or both or all category i.e. Abroad, National & Domestic and they may clearly indicate the category/categories applied for empanelment.

The bidders fulfilling essential eligibility criteria shall be shortlisted and invited for presentation before a Committee. Each of such session will be of maximum 20 minutes duration.

During the interaction/presentation, the shortlisted bidders will be rated on the following parameters:

- Ability to execute shows and the organizational expertise in the field.
- Scale of events executed
- Case presentation on any four of the most significant assignments completed

Highest of Agencies who obtained 50 marks and above out of total maximum marks 100 will be empanelled and ranked as H-1, H-2, H-3, H-4 etc. High ranked EOIs up to six (06) (number may be less than six but not exceeding six) in each category based on the technical capacity criteria shall be shortlisted and invited for empanelment and execution of agreement thereafter.

Tendering process as per provision of relevant General Financial Rules based on estimated value of the event may be invited from the empanelled agencies only as and when the necessity of organising an event arises. Contract may be awarded to lowest one.
