INTRODUCTION:

No other mode of application will be considered & application will not be accepted. However, the firm should submit application/document as described in clause No. (iv)
- iii. For applying online, the Firm should get itself registered at <u>https://nifttenders.eproc.in</u> by paying
 - Registration Charges of **Rs. 2000+360/-**(Inclusive GST) =2360/-(Two Thousand Three Hundred and Sixty Only non-refundable).
 - Bid Processing Fee charges of Rs. 760+137 (inclusive of GST) Total =897 (Eight Hundered Ninety Seven only) through online payments only.
- iv. The Firm should ensure that it complies with the requirements as per works before applying for tender. National Institute of Fashion Technology, Shillong invites E-Tender for "Video Conferencing System" from Distributors/ Authorized Dealers. The details in this regard are given below.

- 1. Procedure to submit the tender: All eligible/interested tenderer are required to be enrolled on Portal <u>https://nifttenders.eproc.in/</u> before downloading tender documents and participate in e-tendering. The vendors should submit online tender in two bid system i.e. Technical Bid and Commercial/ Financial Bid. (BOQ)
- 2. Technical Bid: The technical bid shall contain the following documents. The Bidder must Scan the documents and upload all these documents online with first page in technical bid compulsorily. All the documents must be valid and self-attested by bidder. Non-submission of following requested documents may lead to rejection ofoffers.

1. Financial Bid:-The tendering authority will first open the Technical Bid documents of all bidders and after scrutinizing these documents will shortlist the Bidders who are

eligible for Financial Bidding process. Otherwise the tender may be disqualified. Financial bid should be submitted online by Vendor in Appendix-A in the form of BOQ excel sheet given over <u>https://nifttenders.eproc.in</u>, the supplier shall fill up the column of rate per unit offered by him.

- 3. Bidder should have valid Digital Signature Certificate (DSC) obtained from any Certifying Authorities.
- 4. The specifications/details of the "Video Conferencing System" are provided in the tender documents.
- 5. The Technical and Financial bid shall be submitted online as per the schedule.
- 6. Bidder may be invited for discussions in Institute, ifneeded/required.
- 7. The Bidders are strictly advised to follow the dates and times allocated to each stage. As indicated in the time schedule. All the online activities are time tracked and the Electronic Tendering System enforces time-locks that ensure that no activity or transaction can take place outside the Start and End Dates and Time of the Stage as defined in the tender schedule. At the sole discretion of the Tender Authority, the time schedule of the Tender stages may be extended.
- 8. Rate to be quoted should be mentioned at appropriate place in provided in Schedule (BOQ) by the bidder, more over the rate should not be quoted anywhere else in the tender booklet as well as in the blank pages.
- 9. The institute reserves the right to decide whether to open or not open the commercial Bid of the supplier and no objection of any supplier shall be entertained on any ground whatsoever it may be regarding this.
- 10. No Bid shall be accepted without payment by online earnest money deposit and tender fee.
- 11. The rate should be inclusive of GST.
- 12. The rate should be offered for only the item as mentioned in the Schedule.
- 13. The rates quoted for the items other than specifications specified in the tender form shall not be considered for comparison of rate.

General Terms and Conditions:

- 1) The online tender is called for 'Video Conferencing System
- 2) <u>Earnest Money Deposit -</u> Vendors are required to pay **Rs 47,500**/-(Fourty seven thousand Five hundred Only) as EMD respectively through DD to NIFT, Shillong.
- **3) Security Deposit:** The successful bidder to whom the work order is given shall be required to deposit an amount equivalent to 7% of total value of work order (inclusive of all GST etc.) as security deposit within 7 days from the date of work order. The security deposit will not carry any interest which shall be refunded after supply and successful installation of the system.
- **4)** Cancellation of Work Order:- Institute reserves the right to cancel the work order in case bidder fails to provide the said service, within the stipulated time, The Institute reserves the right to go for next lowest bidder or other appropriate action will be taken.
- If due to the above mentioned reason work order is canceled, earnest money and security deposit shall be forfeited and also the tender may be allotted to the next lowest tender or the institute reserves the right to take any other appropriate decision including legal action against the bidder to whom work order was given.
- 5) The Bid E.M.D. will be forfeited :
- a) If the bidder withdraws his bid during the period of bid validity specified in the bid.
- b) In case of successful bidder, if the bidder
- i) Fails to sign the contract/ agreement in accordance with the terms of the tender documents.

If the successful bidder fails to commence the work within the period prescribed for delivery, the Institute will entitle to recover penalty as liquidated damages @ 0.5% of total value of invoice each week or parts thereof during which the delay of such stores delays subject to maximum in limit of 5%.
- **11) Site Visit:** Tenderer are to visit the site in-order to get aquinted with the Job to be carried and to informed the NIFT, Authorities in advance on the office hour and working day.
- **12) Price Bid:-** The price bid would be base from the Bidder as L1 quoted in the overall amount not item wise as per **Annxure-E inclusive of GST.**
- **13)** Only online tender submitted through the portal for e-procurement will be consider. (<u>https://nifttenders.eproc.in/</u>)

14) MSME/NICS are exempted from EMD and Proof document of such claims must be submitted.

- **15)** Shifting of the Material/items as mentioned in **Annexure-1** should be bubble wrapping and if any defects or destroyed during the time of shifting the cost of the items would be bear by the vendor.
- **16)** Tender offer must be valid for a period of minimum 90 days from the date of opening of commercial/financial bid. Any offer failing short of the validity period is liable for rejection.
- **17)** Bidder shall quote for "Uninstallation, Shifting and Reinstallation of Video Conferencing System" as per technical specifications provided in the tender documents.
- **18)** Bidders are requested to read the tender document carefully and ensure to comply with all the instructions herein. Non-compliance of the instructions contained in this document may disqualify the bidder from the tendering exercise.
