Important Dates

The students are required to pay the applicable fee as per the schedule mentioned below and to note the NIFT rules on non-payment and re-registration:

- The Student has option of paying the fee for the semester July - December, 2020 in three installments:
 - 35% Fees depositing by 21st September, 2020
 - 35% Fees depositing by 21st October, 2020
 - 30% Fees depositing by 21st November, 2020

Once the payment is done, the students are required to submit the attached proforma for online payment immediately in physical form or by sending an email to badahunlang.dkhar@nift.ac.in and academics.shillong@nift.ac.in immediately.

Confirmation can only be given after submission of the proforma.

Important Instructions to students:

1. *Students who fail to pay the above mentioned fee before the last date will have their names removed from the rolls of the institute without any further notice and they are required to pay re-registration charges of ₹ 5000/- plus late fee @ Rs 100/- per day
No attendance relaxation will be given for classes missed due to nonpayment of fee.
2. The mode of payment of the fees as mentioned above shall only be followed by the students.
3. The refundable component of tuition security deposit will be refunded upon completion/withdrawal from course/permanent transfer to other NIFT campus based on request from the student to be submitted in the no dues form available with accounts dept and to be submitted within 6 months from the date of completion/withdrawal as per NIFT rules.
4. **Repeat Semester Cases / Leave of Absence**
 - 4.1 Students who are joining after repeat semester will be required to pay re-registration fee of ₹ 5,000/- per absenting semester as well as non-refundable annual charges towards Library and Student Development & Medi-Claim fee besides the above mentioned amount.
 - 4.2 Students who had repeat semester in any of their previous semesters are to pay their fee as per the semester they are studying/joining and not as per their year of joining.
5. **Students Availing Education Bank Loan** are required to submit the prescribed bonafide form to **academics.shillong@nift.ac.in**. Further, the processing of bonafide form requires a minimum processing time of 2 to 3 days and therefore students are advised to submit the same at the earliest to avoid last minute rush.
6. **No fee payment will be accepted by cash/cheque and in installments.**
7. **Please note under no circumstance, request for extension of date for remitting the fee will be entertained as the dates are fixed by NIFT Head Office and is applicable to all the students of NIFT across all the centres.**
8. **NIFT will not be entertain any reasons for any delay in payment of fee** and students are requested to kindly ensure that demand draft sent by banks must be superscribed with the words "**Demand Draft for Mr./Ms. Student Name, Dept – FD/AD/MFM/FP and Semester**" in the envelope and also in the reverse side of the Demand Draft. Such students should also inform the bank to send email to NIFT whenever demand drafts are dispatched to our address with tracking details
