Important Dates

Students who fail to pay the above mentioned fee before the last date **05th February 2019** will have their names removed from the rolls of the institute without any further notice and they are required to pay re-registration charges of **Rs. 5000/-** plus fine of **Rs. 1000/-** along with the scheduled fee. No attendance relaxation will be given for classes missed due to nonpayment of fee.

How to Pay:

Students and Guardians are advised to email the proof of payment i.e. Name of the Student, Bank Name, Bank Transaction Number & Date of Transaction to badahunlang.dkhar@nift.ac.in & academics.shillong@nift.ac.in if the same is remitted via NEFT/Online for verification at our end.

For NEFT/Online Payment:

For NEFT/Internet Payment: Please refer to next page and submit the same while remitting the fee online. Unless the Proforma for Online Payment of Requisite Fee is submitted it will be presumed that the fee has not been remitted and necessary late fee will apply as per rules.

For Bank Deposit by Challan:

• Students need to obtain the challan from the accounts dept and deposit the fee directly in the Union Bank of India, Police Bazar, GS Road, Shillong as per the account details mentioned above.

For Demand Draft Deposit:

• <u>Fee must be paid by two separate Demand Drafts</u>, one for Tuition Fee and the other for Girls Hostel Fee in <u>favour of "**NIFT Shillong**", payable at **Shillong**. The name of the student, department and semester must be mentioned on the reverse side of the DD.</u>

Important Instructions to students:

- <u>Students who are joining after repeat semester</u> will be required to pay re-registration fee of Rs. 5,000/per absenting semester as well as non-refundable annual charges towards Library and Student Development & Medi-Claim fee besides the above mentioned amount.
- 2. <u>Students Availing Education Bank Loan</u> are required to submit the prescribed bonafide form to <u>academics.shillong@nift.ac.in</u>
- 3. No fee payment will be accepted by cash/cheque and in installments.
- 4. For hostel facility withdrawal, 2 (Two) months prior notice is required from students willing to opt out of the Girls Hostel along with a consent letter from their parents & approved by hostel committee failing which two months hostel fee will be payable.
- 5. <u>Please note under no circumstance, request for extension of date for remitting the fee will be</u> <u>entertained as the dates are fixed by NIFT Head Office and is applicable to all the students of</u> <u>NIFT across all the centres.</u>
- 6. <u>NIFT will not be entertain any reasons for any delay in payment of fee</u> and students are requested to kindly ensure that demand drafts sent by posts must be superscribed with the words "<u>Demand Draft for</u> <u>Mr./Ms. Student Name, Dept FD/AD/MFM/FP and Semester" in the envelope and also in the reverse side of the Demand Draft.</u>
