#### ACTIONS TAKEN BY THE INSTITUTE:

## Formation of Monitoring cell, Anti-ragging Committees & Squads:

Complying with the directive of the Hon'ble Supreme Court of India and as per the UGC regulations, the Institute has formed Monitoring Cell, Anti-Ragging Committee and squads for overseeing the implementation of the provisions of the verdict with immediate effect. The committee will also take necessary steps to prohibit, prevent and eliminate the scourge of ragging including any conduct by any student(s) directed against a fresher or a fellow student. To achieve these objectives a committee has been constituted which will collect the report with evidences from SDAC and recommend necessary steps as defined in NIFT Academic Manual, NIFT Student Rule Book.

#### Institute level Monitoring Cell:

A cell consisting of Director and senior Faculty members will monitor the anti-ragging measures adopted and precautions taken to eradicate ragging from the campus.

#### Anti-ragging Committee:

A committee chaired by SDAC consisting of faculty members nominated by the Director. The Chairperson of the Committee has constituted sufficient number of Anti- ragging Squads involving hostel managers, members of SDAC CLUBS, administrative staff and student representatives.

#### Anti-Ragging Hot-line and Complaint Box:

Ms. Thrice Petal Sancley, Assistant Warden - 8794721187, Shri. S A Rynjah, MPS, SP City - 8575040889, Police Control Room - 0364- 2222214/2222215 will function as a 24x7 hour anti- ragging hot-line of the Institute. Any complaint received on this line will be immediately attended & forwarded to SDAC (sdac.shillong@nift.ac.in) for taking further action which may include collection of evidences and recording statements of all involved and submit a report with proper documentation to the 24x7 anti ragging committee for further action. A complaint box has been placed outside the Directors Chamber and any complaint received in the box will be sent to SDAC. Besides this complaints of any nature may be emailed to hostel, shillong@nift.ac.in and nift.shillong@nift.ac.in

#### Counseling of Fresher's and seniors:

Director of the institute and SDAC will address the incoming students and senior students and make them aware of the seriousness of ragging and how civil and sensible it is to wipe out such acts from an Institute like NIFT. Also special awareness programme will be conducted by experts invited from outside of NIFT.

## Undertaking from Students and Parents:

Each student of the Institute and his/her parents and/or Guardian are hereby required to submit a combined undertaking at the time of registration, in the prescribed format as attached to this order, which is mandatory to registration. Also, senior students are required to submit undertaking in this regard which will be placed in original in their personal file and photocopy sent by speed post to their parents/guardians. It is imperative for all employees of the Institute (teachers, administrative staff, contract staff, caretakers, security staff, maintenance staff and cleaning staff) to report promptly any case of ragging/misbehaviour that comes to his/her notice to a member of the anti-ragging committee or squads. All concerned officials of the Institute, students, parents and guardians of the students, members of Anti-Ragging Committees and Anti-Ragging Squads are hereby requested to adhere to the stipulations and effectively monitor and comply with the provisions made in directives.
