- 1. It is compulsory to carry a photo ID such as Aadhaar Card, Voter ID Card, Driving License, ID issued by Government or any other offices where the candidate has been working. Candidates without ID cards will not be permitted to enter in the examination hall/ Skill Test and Interview venues.
- The candidates are required to report for examination and interview at 09:30 am at G-1, Ground Floor, New Building NIFT – Delhi Campus.
- 3. The Structure of examination is as follows:
 - Written test 50 marks. Written test will have following components:
 - English language and Comprehension,
 - General Awareness
 - Quantitative Aptitude & reasoning Assessment
 - Domain Knowledge of Anthropology and Ergonomics
 - Skill test for testing domain knowledge 20 marks
 - Interview 30 marks.
- Candidates must write the exam/ indicate the answer in their own hand writing.
- Use of mobile phone, calculator and other electronic gadgets and their accessories are not permitted and hence these items are not to be brought inside the examination premises/ venue.
- 6. Candidature of any candidate found to posses mobile phone or any wireless communication device or related accessories either in the working or switched off mode, shall be cancelled.
- 7. The candidates are advised to desist from the use of any influence/ unfair method in the examination hall which will render them disqualified and also lead to their debarment from NIFT's examinations in future besides inviting criminal prosecution.
- The candidate will also be required to bring original documents and one self attested copy of the educational and experience Certificate for verification during the interview.
- Wrong declarations/ submission of false information/ documents or any other action contrary to law shall lead to cancellation of the candidature at any stage.
- 10. The mere possession and fulfilling the essential qualification and appearing for the test and interview don't entitle the applicants to be selected.
- Candidates are advised to make their own arrangement for transportation and stay in Delhi.
