3. IMPORTANT INSTRUCTIONS

a) While applying on Deputation basis:

- i) Period of deputation shall be three years. Tenure can be extended for a maximum period of two more years. Others terms and conditions of deputation will be governed as per Govt. of India Orders/ Instructions on the subject.
- ii) Applications only in the prescribed proforma (as per **Annexure-I**) of the eligible candidates whose services can be spared immediately on selection, together with the certificate (As per **Annexure-II**) from the Forwarding Authority alongwith the following documents may be sent to us:
 - a) Integrity Certificate
 - b) List of major/minor penalties imposed, if any, on the official during the last 10 years; if no penalty has been imposed a "NIL" certificate should be enclosed.
 - c) Vigilance Clearance Certificate
 - d) Attested photocopies of the ACRs for the last five years (2014-15 to 2018-19). Each page should be attested by an officer not below the rank of an Under Secretary to the Govt. of India)
- iii) The Concerned department while forwarding application shall certify that the applicant, if selected, will be relieved within one month of the receipt of the Offer of Appointment.
- iv) The pay of the selected candidate will be regulated under the provisions contained in the DoP&T O.M. No. 6/8/2009-Estt.(Pay II) dated 17.06.2020 as amended from time to time.

b) While applying on Direct/Contract basis:

- i. Age relaxation for direct recruitment posts will be as per Gol / NIFT rules issued from time to time.
- ii. Age relaxation to SC/ST/OBC as per Gol rules. No provision for reservation exists for the posts to be filled up on deputation basis.
- iii. Age relaxation to physically Handicapped (PH) persons as per Gol rules. The persons claiming age relaxation under this sub-para would be required to produce a certificate in prescribed proforma in support of their claims clearly indicating that the degree of physical disability is 40% or more. In any case, the appointment of these candidates will be subject to their being found medically fit in accordance with the standards of medical fitness as prescribed by the Government for each individual Group 'A' posts to be filled by Direct Recruitment by Selection.
- iv. Period of contract shall be three years. Tenure can be extended for a maximum period of two more years.

c) GENERAL INSTRUCTIONS FOR DEPUTATION AND DIRECT/CONTRACT BASIS:

- i) The applicant must be a citizen of India.
- ii) The prescribed qualifications are the minimum and the mere possession and fulfilling the essential and desirable qualification of the same does not entitle the applicants to be called for the interview

- iii) All applicants must fulfill the essential requirements of the post and other conditions stipulated in the advertisement as on the last date of receipt of the applications. They are advised to satisfy themselves before applying that they possess at least the essential qualifications and experience laid down for the post as on the last date of receipt of applications. No enquiries with reference to eligibility will be entertained.
- iv) The application should be accompanied by self attested copies of the relevant educational qualification, experience and Caste/ category (wherever applicable). Incomplete application not accompanied with the required certificates / documents/ unsigned are liable to be rejected.
